21. General Architectural Description

Situated on a prominent corner lot in downtown Louisville, this commercial building features a tall one-story rectangular plan. The structure is supported by a stone foundation, covered with painted concrete pargeting. The building's primary exterior walls - facing toward Main and Pine Streets on the west and south elevations - are comprised of pale blue pressed metal, in a faux stone pattern. The building's original north elevation was also cladded with pressed metal. The east (rear) elevation wall is cladded with painted pale blue vertical wood siding. Parapet walls extend well above the roof lines on the west and south elevations. The parapets are decorated with distinctive cornices, with dentil courses, and with a cannonball finial located at the north end of the west elevation. A recessed corner storefront entryway, topped by a gabled pediment, opens onto the concrete sidewalk at the corner of Main and Pine Streets (southwest corner of the building). Paired, stained natural brown, glass-in-woodframe entry doors, each with one large oval light, and topped by a single transom light, opens onto a brick paved floor in the recessed entryway. A large, single-light fixedpane storefront display window, with painted purple wood frames and surrounds, and covered by a burgundy color canvas awning, is located on the west elevation, to the north of the corner entry. Windows along the south elevation include two 28-light fixed-panes, four 1/1 double-hung sash, and one single-light fixed-pane with a rounded arch, all with painted blue wood frames and surrounds, all topped by distinctive segmental cornices, and all with burgundy color canvas awnings. Two signs extend from the building's wall, above the corner entry, advertising "Karen's Country Kitchen", and "Bakery, Gifts, Dining." Additional sign's advertising the business are located on the west and south elevations. Two service entrances are located on the building's east (rear) elevation.

29.Construction History (include description and dates of major additions, alterations, or demolitions:

This lot was originally built on in 1894. The extant building evidently dates to 1905. At some point, during the early years of the twentieth century, the building was extended toward the alley to the east. More recently, the building has been connected to 702 Main Street next door to the north. Both building's are now part of Karen's Country Kitchen.

This building is located at the northeast corner of main and Pine Streets, in Louisville's downtown commercial district.

35. Historical Background

According to *The Louisville Story*, by Carolyn Conarroe, the first building on this lot was constructed in the early 1894, and was the Tego Brothers Drugstore, which later became known as the Louisville Drugstore. Sanborn insurance maps corroborate that a building was constructed here between 1893 and 1900, and that it was in fact a drugstore. The 1908 Sanborn map depicts a different building here, with a corner storefront and a "footprint" which matches the extant building. Sources indicate that this was a new building constructed as the Louisville Bank in 1905, and not a modification of the wood frame drugstore, which had been built here in 1894.

During the early twentieth century, this new building housed the Louisville Bank. Edward Affolter, a prominent Louisville citizen, was one of the bank's early managers, and later became the building's owner. An lawyer, Affolter served as the Louisville City Attorney for many years, and he had his law offices in this building from 1907 to circa 1950. A democrat, Affolter also served in the Colorado State Senate from 1912 to 1915, and again from 1932 to 1936. Following its use as a bank, this building served as the Louisville Post Office, at least into the 1940s. In 1951, offices for the Louisville - Lafayette Coal Company were located here. By the late 1950s, this building had become the Varra Grocery Store. The Varras (Albert and Elizabeth) purchased the property from Edward Affolter in November 1961. Varra's Grocery was gone by the mid-1960s, and in the ensuing years the building served as a florist's shop, an antique store, and as a pottery center. In 1974, Karen and John Mulholland opened Karen's Country Kitchen, a cafe and gift shop in the building. Having been in business now for more than a quarter century, Karen's Country Kitchen has expanded into the building next door to the north, and has become a downtown Louisville landmark.

This building has been individually listed in the National Register of Historic Places. It is historically significant, relative to National Register Criterion A, for its association with commercial development in downtown Louisville through the first half of the twentieth century. The building is architecturally significant as well, under National Register Criterion C, as an excellent example of corner storefront commercial building dating from the very early years of the twentieth century. The building is also Louisville's only remaining commercial building with a pressed metal facade.




