21. General Architectural Description

The Colacci Restaurant building is located on the east side of Main Street, in downtown Louisville. The original building, to the west, measures approximately 35' by 70', and is of wood frame construction. The rear of the building. to the east, measures approximately 32' by 55', and is of concrete block construction dating from the 1950s. The building rests on a concrete or stone foundation, and the roof is flat. A parapet wall extends approximately three feet above the roof line, on the facade (east elevation), while somewhat lower parapet walls are located along the north and south elevations. The building's facade features a glassin-steel-frame door, set within a recessed entryway. The door is flanked, within the entryway, by two glass-in-steelframe windows. Another glass-in-steel-frame door, is located to the south of the main entry, and there are two glass-insteel frame storefront display windows, on the facade. The lower facade wall is faced with pressed concrete, in a faux buff red sandstone pattern. The upper facade wall is cladded with an applied metal facade, light beige in color, with a wide bright blue band. A large distinctive neon sign projects out from, and above the upper facade wall, advertising "Colacci's Restaurant." The east end of the building's south elevation is exposed, an four 1x1 horizontal sliding windows, in metal frames, are located here. Two similar windows are located on the building's east (rear) elevation, and there are two service entry doors, located on the east elevation, as well.

29.Construction History (include description and dates of major additions, alterations, or demolitions:

Sanborn Assessor maps, dated 1900 and 1908 provide evidence that this building was constructed sometime during those years. A 32' by 55' concrete block addition was put on the rear of the building in 1955. The building's facade was renovated, as the building was converted from a pool hall into Colacci's Restaurant, at the same time. Boulder County Assessor records suggest that the facade may have been renovated again in 1988.

Colacci's Restaurant is located on the east side of Main Street, in the heart of downtown Louisville. Tulien's Restaurant is to the south, and the Main Street Market Place building is to the north.

35. Historical Background

Sanborn insurance maps reveal that this building was constructed shortly after the turn of the twentieth century, and that early on an undertaker's business was located here. By 1936, Steven John was operating a beer parlor here. Within a few years, this establishment had become a billiards hall called "Johnnie's Place." Louis Schmelzer is listed as the business' manager in the 1940 Boulder County Directory. By 1950, Toney W. and Catherine LaSalle were operating the LaSalle Furniture Store at 816 Main Street. LaSalle's Furniture and Household Goods had previously been located at 813 Main Street, according to Boulder County Directories.

In 1955, this building was acquired by Anthony and Rita Colacci who opened Colacci's Restaurant here. Anthony is the son of Michael and Mary (Maria) Colacci, who had come to Louisville in the 1910s. The Colacci family, over the course of several decades, made an indelible mark on downtown Louisville, as they operated up to four Italian restaurants in a two block area along Main Street. The Colacci family's first restaurant, the Blue Parrot, has operated continuously at the southeast corner of Main and Pine Streets since the early 1920s. Other Colacci restaurants include: Colacci's Restaurant, which opened here at 816 Main Street in 1955; Luigi's, located at 808 Main Street from the mid-1960s to the mid-1980s; and Pasquale's, which was in business at 809 Main Street from the mid-1960s until 1997. Due primarily to the Colacci family, Louisville gained a reputation throughout the Denver metropolitan area as the place to go for Italian food. The Colacci's were involved in other retail businesses as well. In the 1940s and 1950s, Joseph Colacci (Michael and Mary's son) ran Tony and Jim's Service Station (later known as the Louisville Oil Company), at the northwest corner of Main and Pine, located diagonally across the street from the Blue Parrot. Joe Colacci later took over operation of the Blue Parrot, while his brother, Anthony, ran Colacci's Restaurant here at 816 Main Street. Earlier this year (2000) Colacci's Restaurant was acquired by Tony Pasquini, and the name was changed to Pasquini's Pizzeria. It remains a very popular Louisville eatery.

42. Statement of Significance

The Colacci's Restaurant building is historically significant, relative to National Register Criterion A, for its association with commercial development in Louisville during the first half of the twentieth century. The building is also important for its association with the Colacci family, and Louisville's rich heritage of Italian restaurants. This association, though, postdates the period of significance.

43. Assessment of historic physical integrity related to significance:

Substantially remodeled in 1955, and perhaps again in 1988, this building bears little resemblance to what it looked like during the period of significance. A comparison of the extant building, with an appraisal card photo from the period of significance, reveals a considerable loss of integrity. The building, thus, is no longer able to convey a sense of its historic significance. It may be regarded as ineligible for individual listing in the National Register of Historic Places, and as a non-contributing property within a potential downtown Louisville historic district.




