21. General Architectural Description

This wood frame residence is supported by a concrete foundation, and features painted pale yellow horizontal weatherboard exterior walls, with painted green 1" by 4" corner boards. The roof is hipped, with flared eaves, and with grey asphalt shingles. A hipped-roof dormer, with one 1/1 double-hung sash window, is located on the east elevation (facade). A single red brick chimney is located near the west end of the roof ridge. A large canted hipped-roof bay window, with three 1/1 double-hung sash windows, is located on the north elevation. Windows elsewhere are predominantly 1/l double-hung sash with painted white wood frames and painted pale green wood surrounds, and with exterior metal storm windows. A 3-step concrete porch covers the north 2/3s of the east elevation, and wraps around to cover the east end of the north elevation. Representing the house's most notable architectural element, the porch features non-original blond and red brick half-walls, painted buff red Doric columns, and a distinctive porch roof which is an extension of the main roof's flared eave. A dentil course appears along the porch roof eave. Three glass-in-wood-frame entry doors, each with a wood screen door, open onto the porch. A secondary entrance is located at the north end of the west (rear) elevation. Here, a painted white solid wood door, with a white metal storm door, opens onto a concrete stoop. Also, a wood-paneled door, with one upper sash light, located on the south elevation, is no longer in use. A 26' by 8' $\,$ low-pitched hipped-roof addition to the west elevation predates 1950.

A single-car **Garage** is located near the alley and South Street, to the west of the house. This building features a concrete slab foundation and floor, and painted pale yellow horizontal weatherboard walls, with painted pale green 1" by 4" corner boards. The garage is covered by a low-pitched front gable roof with brown asphalt shingles over 1x wood decking and 2x wood rafters. Windows on the garage include two sets of paired shuttered windows on the west elevation, and three 4x4 horizontal sliders, all with painted pale green wood frames. Paired, painted pale yellow and green garage doors, each with six upper sash lights, and with X-bracing, open toward South Street on the north elevation.

Current Boulder County Assessor records list 1920 as this house's date of construction. A 1950 property appraisal card, however, lists 1913 as the date of construction. Both dates are plausible given the dwelling's Classic Cottage style and physical condition. The earlier 1913 date may be more reliable, however. The 26' by 8' low-pitched hipped-roof addition to the west elevation is depicted on the appraisal card, and thus predates 1950.

23. Landscape or setting special features:

This house and garage are located at the southwest corner of Front and South Streets, northeast of downtown Louisville. A planted grass front yard to the east, and side yard to the north, are unfenced. The backyard to the west is enclosed by a woven wire fence. Concrete sidewalks, separated from the curb by narrow strips of grass, parallel Front and South Streets.

Historical Background

Built circa 1913, this house was the residence of John Jacob (J.J.) Steinbaugh, one of Louisville's leading citizens and businessmen from 1890 until his death in 1950. Born in Hanef, Germany in 1868, Steinbaugh immigrated to the United States with his parents in 1885. The family settled in Sheridan, Iowa, but young J.J. soon set out to make his own way in the world. After learning the blacksmithing trade at St. Joseph, Missouri, J.J. traveled west to Salt Lake City, and to Denver where he found employment and gained experience as a blacksmith. Arriving in Louisville in 1890, Steinbaugh opened his own blacksmith shop on Front Street two years later. In the meantime, in 1891, J.J. married Elizabeth (Lizzie) Stretz of Louisville. They had a son, Herman, born in 1982, and two daughters, Gertrude and Amelia. Gertrude passed away at age ten.

In the late 1890s, Steinbaugh expanded his business to include the sale of wagons, buggies, harness, and farm machinery. A few years later, he also began selling hardware. Herman Steinbaugh joined his father in the business at an early age, and was initially involved in the sale of hardware and farm machinery. In 1928, the Steinbaughs added a lumberyard, after purchasing property that had been owned by the Zang Brewing Company at the northwest corner of Front and Spruce Streets. A few years later, the Steinbaughs added the sale of furniture to their extensive line of merchandise. Herman took over as head of the business upon his father's retirement, in 1941. J.J. Steinbaugh passed away nine years later, at the age of 82. Herman, and his wife May, had four sons - Glenn, Herbert, Jack, and Jimmie - all of whom learned the hardware business at an early age. After coming of age, the four brothers eventually took over the business, which by then had become an Ace Hardware affiliate. In 1969, Glenn Steinbaugh became the company's president after buying out his brothers.

On September 1, 1974 the Steinbaugh Lumber Company building burned to the ground in a disastrous arson fire. Rather than closing the business, Glenn decided to persevere by relocating it to the old State Mercantile Building at the northwest corner of Main and Spruce Streets. Steinbaugh Hardware operated in that location until 1997 when it was finally forced to close its doors, driven out of business by Eagle Hardware and Home Depot warehouse stores which had opened nearby. Glenn's son, Tom Steinbaugh, was the business's last owner.

After they were married in 1891, J.J. and Lizzie Steinbaugh moved into a small house located here at the southwest corner of Front and South Streets. In about 1913, J.J. contracted with Mike Fabrizio to build a new residence here. Fabrizio, with help from his father, constructed this Classic Cottage style residence. This was the Steinbaugh family home until 1935 when they moved to a new brick house at the corner of McKinley and Pine. Following the Steinbaughs, this was the residence of John P. and Mary Kakalecik from the late 1950s to the early 1970s. John, who was a miner, passed away prior to 1975, but Mary continued to live here through at least 1980. More recent owners/ residents of this property include John K. Nelson, Timothy Shaughnessy, and C.S. Archer.

42. Statement of Significance

The Steinbaugh House is historically significant primarily for its association with the John Jacob Steinbaugh family who lived in the residence from circa 1913 to 1935. J.J. Steinbaugh was one of Louisville's leading citizens and businessmen from 1892 to 1950. The business he founded in 1892 lasted 105 years, and sustained four generations of the Steinbaugh family, as well as numerous employees. This residence is the building most closely associated with J.J. Steinbaugh's productive life, and consequently it is eligible for inclusion in the National Register of Historic Places under Criterion B. The house is also eligible under Criterion C, for its architectural significance, because it is one of Louisville's best Classic Cottage style homes.

43. Assessment of historic physical integrity related to significance:

This house exhibits an overall high degree of historical integrity relative to National Park Service and Colorado Historical Society guidelines. There have been no additions within the past fifty years, and exterior alterations are minimal. The most notable alteration are the non-original brick half-walls on the front porch. The garage dates from the Steinbaugh era, and should also be considered a historically significant building.




LOCATION MAP
