- 7. Previous Recordings: Architectural Inventory Form 2000, as part of "Old Town" Louisville Historical Building Survey by Carl McWilliams of Cultural Resource Historians.
- 8. Changes or Additions to Previous Descriptions:

Construction History: Boulder County gives 1900 as the year of construction of this house. However, it is the 1908 Sanborn map, as well as the 1909 Drumm's Wall Map of Louisville, that show this house in the correct location and not the 1900 Sanborn map. The house appears to have been constructed between the time of the 1900 Sanborn map and the time of the 1908 Sanborn map.

The house was extensively modified in 2005. At this time yellow horizontal steel siding replaced the original wood siding; windows were replaced with aluminum casement and awning windows; and a 2-story addition was constructed on the east side. The architect was Andrew Kelsev and the contractor was Zen Construction & Design. By 2010, the house had blue painted trim and gray asphalt shingles.

# Change to General Architectural Description:

The 2-story addition has complex hip roofs and is sided with the same yellow steel siding as the rest of the house. On the north side of the addition, there is a projecting bay with a hip roof at the first floor. The bay features one window and a wood panel door with one glass light, providing access to a brick and railroad tie stoop. On the east side, the first floor of the addition extends beyond the second floor. At the north end, it has a 45-degree clipped bay with a hipped roof and fixed or casement aluminum windows, plus a wood door flanked by two sidelights. The door opens to a large brick patio with three railroad tie steps down to the yard.

The second floor of the addition has an outdoor deck at the south end, with a square wire railing. The second floor has slider windows, and a glass-in-wood door providing access to the deck. The south side of the addition is not visible.

Landscape or special setting description: Jefferson Place Subdivision is a historic residential neighborhood adjacent to downtown Louisville. The subdivision is laid out on a standard urban grid of narrow, deep lots with rear alleys. Houses are built to a fairly consistent setback line along the streets with small front lawns, deep rear yards and mature landscaping. Small, carefully maintained single-family residences predominate. Most of the houses are wood framed, one or one and one-half stories in height, featuring white or light-colored horizontal wood or steel siding, gabled or hipped asphalt shingled roofs and front porches. While many of the houses have been modified over the years, many character-defining features have been retained.

Although 608 LaFarge was extensively modified both in the 1950s and in 2005, the house is consistent with these patterns and blends relatively well with the scale and character of the neighborhood. The large 2005 addition is in the rear, retaining the scale of the original one-story cottage along LaFarge.

- 10. Changes to Location or Size Information: Addition of 450 square feet = total 1304 square feet.
- 11. Changes in Ownership: Same ownership as 2000 inventory form.
- 12. Other Changes, Additions, or Observations: Further research has yielded more information about the ownership and use of the building.

The following history gives additional information about the chain of ownership for 608 La Farge Ave., including specific information about families that owned it. It has been found that the Willis family of Louisville was the primary family associated with this property, having owned it for 33 years.

#### Raffaele D Amato ownership, 1902-1926

Lots 10 and 11, which make up this property, were initially sold separately by the developer, Charles C. Welch. In 1898, Welch conveyed twenty-nine different lots in Jefferson Place to a Denver lawyer, Harper Orahood, apparently for Orahood to resell. Lot 10 was one of these lots. Orahood resold it to "Raffaele D Amato" in 1902.

"Rafaele Di Amata" acquired Lot 11 in 1902 as well, but this lot was acquired from previous owners J.H. Gilfillan and, before him, Joseph Davis (the identity of the owner between Davis and Gilfillan could not be located). Davis had acquired it from Welch in 1894.

Thus, Raffaele D Amato was the owner of both lots starting in 1902. The available Boulder County property records indicate that he was the owner until 1926. The 1904 Boulder County Directory for Louisville shows "Raffiel Dammatt" and his wife, Lizzie, living on "Lafarge btw. Pine & Hutchinson," which describes the location of 608 La Farge. His occupation is given as "miner." Unfortunately, no other information about this owner could be located.

Boulder County gives 1900 as the year of construction of this house. However, it is the 1908 Sanborn map, as well as the 1909 Drumm's Wall Map of Louisville, that show this house in the correct location and not the 1900 Sanborn map. The house appears to have been constructed between the time of the 1900 Sanborn map and the time of the 1908 Sanborn map.

In 1926, Nettie Wilson purchased the property from "Raffaele D Amato." She was the wife of Louisville miner Robert Wilson, and owned it just one year.

### Willis Family ownership, 1927-1960

In 1927, the Willis family acquired this property. Members of this family were to own it for 33 years.

According to a 1933 clipping describing the golden wedding anniversary of Margaret and William H. Willis, the two were married in Middlesboro, Yorkshire, England, in 1883 and came to the United States in 1886. They then came to Louisville in 1907. William Willis had been a miner in England and he continued to mine in the Louisville area. They had four daughters and a son, including Elizabeth Willis (sometimes referred to as Mary Elizabeth) and Robert Willis, both of who became residents of 608 La Farge. According to Louisville Cemetery records, William Willis lived 1860 to 1944 and Margaret lived 1864 to 1935.

In 1927, Margaret Willis acquired the property at what is now 608 La Farge. In 1934, she conveyed it by quit claim deed to her daughter, Elizabeth Willis. Directories show that Margaret and William Willis made their home elsewhere in Louisville.

Louisville directories show that the Willis's son, Robert Willis, and his wife, Nelle Wolfer Willis, were residents of this house in 1928 and 1930. Robert was a coal miner. The address for this property at that time was 117 La Farge. Robert and Nelle Willis are also shown as living on La Farge in 1940, and they are shown as specifically living at 608 La Farge in 1943. They had one child, Mary Kathryn.

The 2000 Cultural Resource Survey is correct that according to the 1951 directory, 608 La Farge was the residence of Gregory and Helen James, but they were not significant to the history of this house. Because they were not the legal owners, it is believed that they were renters. Also, this was the only directory in which they are listed as living at this address.

Next, the legal owner, Elizabeth Willis, did make this property her home. Her listed address is 608 La Farge in the directories for 1952-53, 1953, 1956, and 1958. Her occupation is given in directories as both "waiter" and "cafeteria worker."

Elizabeth Willis lived 1883 to 1959. The property left the ownership of the Willis family in 1960.



13B.	District Potential: This building is outside the boundaries of a State Register historic district, local district, and a potential National Register historic district. Due to loss of integrity, the southeast portion efferson Place Subdivision, in which this building is located, is not included within the boundaries.		
	Discuss: This building is being recorded as part of a 2010-2011 intensive-level historical and architectural survey of Jefferson Place, Louisville's first residential subdivision, platted in 1880. The purpose of the survey is to determine if there is potential for National Register, State Register or local historic districts. Most of the Jefferson Place subdivision, but not this portion, is eligible as a State Register historic district under Criterion A, Ethnic Heritage, European, for its association with European immigrants who first lived here and whose descendants continued to live here for over fifty years. The period of significance for the State Register historic district is 1881 – 1980. Jefferson Place is potentially eligible as a National Register historic district under Criterion A, Ethnic Heritage, European. However it needs data to determine dates of some modifications, and to more definitely establish the significant impacts of various European ethnic groups on the local culture of Louisville. The period of significance of a National Register district is 1881 – 1963. Jefferson Place is eligible as a local Louisville historic district under local Criterion B, Social, as it exemplifies the cultural and social heritage of the community.




