Overview of the Colorado Open Records Act, Ethics Disclosures, Public Meeting Reminder and Media Engagement

- Open Government Policy
 - o The City of Louisville encourages citizen involvement and participation in its public policy process.
 - o State policy requirement
- Louisville operates on a Mayor-Council-Manager form of government
- Meetings: If more than 2 members of the Task Force decide to meet "to discuss Task Force business" that is considered an official meeting and it has to be noticed and open to the public. You should not meet privately with more than 2 members of the Task Force outside of the official scheduled meetings to discuss the business of the Task Force.
- The Task Force cannot have substantive discussion of anything that is NOT on the agenda. Further, items cannot be added to the agenda at the meeting.
- E-mails and social media can be recorded for public records if information pertains to EDI work

Overview of City Council Approved EDI Task Force Resolution and Scope of Work for Louisville's EDI Agenda

- January 19th, 2021, Louisville City Council passed a resolution to establish an EDI Task Force. It
 includes information such as the number of members, goals, and missions of the Task Force. The
 Task Force will be focused on the community aspect of EDI.
- The goals of the task force are to identify the most crucial issues regarding EDI in Louisville and draft up possible solutions and recommendations to be considered for implementation.
 Louisville is striving to be a more inclusive and welcoming place for BIPOC individuals.
- Anthony Graves and Emily Shamsid-Deen are the chosen facilitators for the Task Force.
- The timeline for the Task Force is 7 months.
- Louisville is specifically looking for 4-5 priorities to take specific action on through the Task Force's recommendations.

- Nancy Commins: safe and welcoming environment, housing second (Believes language can be infused into all the topics, issue around language affects all the topics stated)
- Y'Anique Duke: Youth engagement Equity and Social Justice (The youth have a lot to say and are impacted by our decisions but have no platform to voice their thoughts, they are the future so we need to listen to them)
- Francisco Estevez: Safe and welcoming environment, housing second (a lot of people feel welcome and safe when an environment represents something familiar to them).
- Grace Gee: Safe and welcoming environment (this is the gatekeeper for people to participate in the community)
- Hazleena Hashim: Youth engagement equity and social justice, safe and welcoming environment second (Mother, Teach the children why these issues are important)
- Devanand Heins: Safe and welcoming environment
- Ronald Reeves: Youth engagement Equity and Social Justice (listening to the youth and understanding the issues that are impacting them)
- Lyanne Terada: Public health (recognizing the basic needs that people are missing and addressing that, addressing the issue of mental health and making sure we are including that as well)
- Lou Yu: Public accommodation, safe and welcoming environment second (Public accommodation is the standard to EDI)
