**BALLOT QUESTION 1 - ORDINANCE NO. 981, SERIES 1989**

AN ORDINANCE PROVIDING FOR THE IMPOSITION OF A 3.00% CITY SALES TAX ON THE SALE OF TANGIBLE PERSONAL PROPERTY AT RETAIL OR THE FURNISHING OF SERVICES; CREATING A CAPITAL IMPROVEMENT FUND TO BE FUNDED WITH ONE-THIRD OF THE REVENUES GENERATED BY THE 3.00% SALES TAX; PROVIDING FOR THE IMPOSITION OF A 3.00% CITY USE TAX FOR THE PRIVILEGE OF USING OR CONSUMING COMMERCIAL CONSTRUCTION AND BUILDING MATERIAL, AND STORING USING, OR CONSUMING ANY MOTOR AND OTHER VEHICLES; PROVIDING FOR THE REPEAL OF INCONSISTENT ORDINANCES; AND PROVIDING FOR THE SUBMISSION OF THIS ORDINANCE FOR APPROVAL AT A SPECIAL MUNICIPAL ELECTION OF THE CITY ON MARCH 21, 1989.
