BALLOT ISSUE 2A

WITHOUT INCREASING ANY CURRENT TAX RATE OR ADDING ANY NEW TAXES, SHALL THE CITY OF LOUISVILLE, COLORADO ("CITY") BE AUTHORIZED TO COLLECT, RETAIN, AND EXPEND ALL REVENUES COLLECTED AND RECEIVED BY THE CITY DURING THE YEAR 1998 AND EACH SUBSEQUENT YEAR FROM FEES, STATE AND LOCAL GRANTS, DEVELOPER CONTRIBUTIONS, INTERGOVERNMENTAL REVENUES AND PAYMENTS IN LIEU OF LAND DEDICATIONS, TO BE USED FOR CAPITAL PROJECTS, MUNICIPAL OPERATIONS AND SERVICES, OR ANY OTHER LEGAL PURPOSES OF THE CITY, NOTWITHSTANDING ANY STATE RESTRICTION ON FISCAL YEAR REVENUE AND SPENDING, INCLUDING WITHOUT LIMITATION THE RESTRICTIONS OF ARTICLE X, SECTION 29 OF THE COLORADO CONSTITUTION (WHICH IS COMMONLY KNOWN AS AMENDMENT 1 AND/OR THE TABOR AMENDMENT) OR ANY OTHER LAW:

BALLOT QUESTION 2B

SHALL PROVISIONS OF CHAPTER 2 OF THE LOUISVILLE MUNICIPAL CODE, CONCERNING THE SALARIES FOR THE MAYOR, COUNCILMEMBERS, CITY CLERK AND CITY TREASURER, BE AMENDED TO INCREASE THE SALARIES OF THESE ELECTED CITY OFFICIALS AS FOLLOWS: FOR THE MAYOR, FROM TWENTY-FOUR HUNDRED DOLLARS PER YEAR TO SIX THOUSAND DOLLARS PER YEAR; FOR EACH COUNCILMEMBER, FROM TWELVE HUNDRED DOLLARS PER YEAR TO THREE THOUSAND DOLLARS PER YEAR; FOR THE CITY CLERK, FROM ONE THOUSAND EIGHT HUNDRED DOLLARS PER YEAR TO THREE THOUSAND DOLLARS PER YEAR; AND FOR THE CITY TREASURER, FROM EIGHTEEN HUNDRED DOLLARS PER YEAR TO THREE THOUSAND DOLLARS PER YEAR?
