BALLOT ISSUE 2A

WITHOUT INCREASING ANY CURRENT TAX RATE OR ADDING ANY NEW TAXES, SHALL THE CITY OF LOUISVILLE, COLORADO ("CITY") BE AUTHORIZED TO COLLECT, RETAIN, AND EXPEND THE FULL PROCEEDS OF THE CITY'S PROPERTY TAXES COLLECTED AND RECEIVED BY THE CITY DURING THE YEAR 2001 AND EACH SUBSEQUENT YEAR, FOR OPEN SPACE AND PARKS MAINTENANCE, CAPITAL PROJECTS, MUNICIPAL OPERATIONS AND SERVICES, OR ANY OTHER LAWFUL GOVERNMENTAL PURPOSES OF THE CITY, NOTWITHSTANDING ANY STATE RESTRICTIONS ON FISCAL YEAR REVENUE AND SPEEDING, INCLUDING WITHOUT LIMITATIONS, THE RESTRICTIONS OF ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION (WHICH IS COMMONLY KNOWN AS AMENDMENT 1 OR THE TABOR AMENDMENT), C.R.S. SECTION 29-1-301 ET SEQ. (WHICH IS COMMONLY REFERRED TO AS THE 5.5 PERCENT TAX REVENUE LIMIT), OR ANY OTHER LAW?
