STATEMENT AND CERTIFICATE OF DETERMINATION  
OF A SPECIAL ELECTION HELD IN LOUISVILLE,  
COLORADO ON TUESDAY, NOVEMBER 2, 2004**

**BALLOT ISSUE 2A**

**TOTAL VOTES**

SHALL CITY OF LOUISVILLE HOME RULE CHARTER BE AMENDED TO REPLACE THE CURRENT REQUIREMENTS ON CITY COUNCIL STUDY SESSIONS WITH REQUIREMENTS APPLICABLE TO STUDY SESSIONS OF ALL CITY PUBLIC BODIES; TO EXTEND THE PROHIBITION ON FINAL DECISIONS AT STUDY SESSIONS TO PRELIMINARY OR FINAL DECISIONS; TO REQUIRE 72 HOURS NOTICE OF ALL STUDY SESSION AND MEETINGS OF CITY PUBLIC BODIES, OTHER THAN EMERGENCY MEETINGS OF CITY COUNCIL; TO ADD PROCEDURES AND CRITERIA FOR ASSERTED VIOLATIONS OF THE STANDARDS FOR CONDUCT OF STUDY SESSIONS; TO REQUIRE THAT A WRITTEN RECORD OF STUDY SESSIONS BE PREPARED WITHIN FIVE DAYS OF SUCH SESSION; TO REQUIREMENTS ON CITY PUBLIC BODIES OCCUR IN PUBLIC BUILDINGS AND FACILITIES ACCESSIBLE TO ALL MEMBERS OF THE PUBLIC; TO REQUIRE THAT CITY OFFICIALS PARTICIPATE IN AT LEAST ONE OPEN GOVERNMENT-RELATED SEMINAR EVERY TWO YEARS; TO REQUIRE THAT THE CITY PUBLISH A FREE PAMPHLET SUMMARIZING ARTICLES 4 AND 5 OF THE CHARTER AND OTHER LAWS RELATING TO CITIZEN PARTICIPATION IN MUNICIPAL GOVERNMENT; TO PROHIBIT FEES FOR INSPECTION OF CITY RECORDS AND TO LIMIT FEES FOR ASSEMBLING AND COPYING CITY RECORDS TO, RESPECTIVELY, ACTUAL LABOR COSTS AND ACTUAL COPYING COSTS; TO REQUIRE THE MAINTENANCE OF A COMMUNICATION FILE REGARDING MATTERS ON PAST OR FUTURE CITY COUNCIL AND PLANNING COMMISSION AGENDAS; THE REQUIRE THAT AGENDA-RELATED MATERIALS FOR EACH CITY PUBLIC BODY BE MADE AVAILABLE TO THE PUBLIC AND IN ELECTRONIC FORMAT IF AVAILABLE; TO REQUIRE PREPARATION OF A PLAN FOR WEB-SITE DISSEMINATION OF AGENDA-RELATED MATERIAL; TO PROHIBIT CITY COUNCIL OR PLANNING COMMISSION DISCUSSION OR CONSIDERATION OF ANY DOCUMENT SUBMITTED TO THEM AT A MEETING UNLESS THE DOCUMENT IS IMMEDIATELY MADE AVAILABLE TO THE PUBLIC; TO PROHIBIT CITY PUBLIC BODIES FROM ENGAGING IN SUBSTANTIVE DISCUSSIONS OF ANY SUBJECT THAT IS NOT LISTED ON THE PUBLIC BODY'S MEETING AGENDA OR SUBSTANTIALLY RELATED TO A SUBJECT LISTED ON THE AGENDA, UNLESS SUCH DISCUSSIONS ARE PERMITTED WITHIN THE PARAMETERS OF AN EMERGENCY MEETING OR UPON FINDINGS BY THE PRESIDING OFFICER; TO ADD PROCEDURES AND CRITERIA FOR ASSERTED VIOLATIONS OF THE FOREGOING PROHIBITION ON SUBSTANTIVE DISCUSSIONS; TO ADD CERTAIN DEFINITIONS RELATED TO THE FOREGOING AMENDMENTS; AND TO PROVIDE THAT, IN THE EVENT OF CONFLICT; AMENDMENTS TO THE CHARTER SUPERSEDE PRIOR AMENDMENTS TO OR VERSIONS OF THE CHARTER?
