Public Hearing Schedule and Public Notice Deadlines for Complete Applications

After a land-use application has been submitted, has completed the iterative development review process, and staff deems the application to be complete, the application can be scheduled for a public hearing. All final application materials, requiring no further revisions, must be submitted to the city at least six weeks prior to the first public hearing.
