WHEREAS, the City desires to approve an Intergovernmental Agreement, by and among the City, the County of Boulder, and the Louisville Fire Protection District ("District"), for the District's access to and use of the mail ballot drop-off box and surveillance system at the Louisville Recreation & Senior Center in connection with District's May 2023 election (the "Agreement"); and

WHEREAS, the City Council by this Resolution desires to approve the Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LOUISVILLE, COLORADO:

<u>Section 1</u>. The Intergovernmental Agreement, by and among the City, the County of Boulder, and the Louisville Fire Protection District ("District"), for the District's access to and use of the mail ballot drop-off box and surveillance system at the Louisville Recreation & Senior Center in connection with District's May 2023 election, a copy of which Agreement accompanies this Resolution, is hereby approved.

<u>Section 2</u>. The Mayor is hereby authorized to execute the Agreement, and the Mayor is hereby further authorized to negotiate and approve such revisions to the Agreement as the Mayor determines are necessary or desirable for the protection of the City, so long as the essential terms and conditions of the Agreement are not altered.

INTERGOVERNMENTAL AGREEMENT

THIS INTERGOVERNMENTAL AGREEMENT (the "Agreement") is entered into this ____ day of March, 2023, by and among the Board of County Commissioners on behalf of the County of Boulder, State of Colorado, a body corporate and politic, for the benefit of the Boulder County Clerk and Recorder (the "Clerk"); the City of Louisville, a Colorado municipal corporation whose address is 749 Main Street, Louisville, CO 80027 (the "City"); and the Louisville Fire Protection District (the "District"). The Clerk, the City, and the District may be collectively referred to as the "Parties."

WHEREAS, the Clerk and the City entered into an Intergovernmental Agreement ("IGA") on May 4, 2021, which allowed the Clerk to install a mail ballot drop-off box at the Louisville Recreation Center (the "Property"), which is owned by the City, and to use and have access to the City's video surveillance recording system at the Property to monitor the mail ballot drop-off box; and

WHEREAS, the Clerk has funded the entire cost of obtaining, installing, and maintaining the mail ballot drop-off box since that time, and the Clerk controls the mail ballot drop-off box; and

WHEREAS, the City controls the video security surveillance recoding system on the Property; and

WHEREAS, the District is conducting an election on May 2, 2023 (the "Election") and wishes to use the mail ballot drop-off box and video security surveillance recording system during the Election to provide a convenient location for District voters to drop off their completed mail ballots (the "Purpose"); and

WHEREAS, the Clerk wishes to authorize use of the mail ballot drop-off box to the District during the Election; and

WHEREAS, the City wishes to authorize use of the video surveillance recording system to the District during the Election; and

WHEREAS, intergovernmental agreements are authorized and encouraged by Article XIV, Section 18 of the Colorado Constitution and Colo. Rev. Stat. § 29-1-203.

NOW, THEREFORE, in consideration of the recitals, promises, covenants and understandings set forth herein, the Parties agree as follows:

1. <u>Term of Agreement</u>. The term of this agreement is **March 14, 2023 to May 10, 2023** (the "Term").

2. Existing IGA. This Agreement stands apart from the May 4, 2021, Intergovernmental Agreement between the Clerk and the City. It does not replace or amend the IGA.

3. Use of the Mail Ballot Drop-Off Box.

- a. <u>License</u>. The Clerk grants a limited license to the District to use the mail ballot drop-off box during the Term for the Purpose.
- b. Keys to the Mail Ballot Drop-Off Box. The Clerk will provide the District with all keys to the mail ballot drop-off box by March 14, 2023. Only the representatives of the District will have the key(s) to the mail ballot drop-off box. The District is responsible for securely maintaining the mail ballot drop-off box during the Term, retrieving mail ballots during the Term, and for ensuring the box's closure on Election Day.
- c. <u>Access to Mail Ballot Drop-Off Box</u>. The City grants access to the District to access the Property in order to collect ballots from the mail ballot drop-off box during the Term.

4. Use of the Video Security Surveillance Recording System.

- a. Video Security Surveillance Recording System. The City and the Clerk will enable the video security surveillance recording system from April 10, 2023 to May 3, 2023. The Clerk will export the video surveillance footage ("Footage") to a storage device purchased by the District and provided to the Clerk ("Storage"). The District will comply with all applicable laws and regulations governing video surveillance of mail ballot drop-off boxes. If the City or the Clerk become aware of a problem with the video security surveillance during the Term, the City or the Clerk will notify the District, and the City, the Clerk and the District will cooperate in good faith to correct the problem.
- b. <u>Retention of Video Data.</u> After the Clerk exports the Footage to Storage, the District will be responsible for retaining the Footage. The City and the Clerk have no obligation to retain Footage after export to Storage.
- 5. <u>District Conducting the Election</u>. The District is conducting the Election and is responsible for complying with all election-related laws and regulations.
- 6. <u>Signage</u>. The District will temporarily cover the Boulder County decal on the mail ballot drop-off box to identify the box as controlled by the District during the Term.
- 7. <u>Damage to Property</u>. The District will pay the Clerk for repair and/or replacement of the mail ballot drop-off box if damaged by anyone other than the Clerk during the Term. The District will pay the City for repair and/or replacement of the video

security surveillance recording system if damaged by anyone other than the City during the Term. Notwithstanding any provision to the contrary, nothing in this Agreement will be construed in any way to be a waiver by any Party to the protection that is granted under the Colorado Governmental Immunity Act, C.R.S. 24-10-101, et. seq.

- 8. <u>Termination</u>. Upon termination of this Agreement, the District will remove any District signage no later than **May 5, 2023**.
- 9. <u>Notices</u>. Any notices to be provided under this Agreement must be given in writing and either delivered by hand, by email, or deposited in the United States mail with sufficient postage to the addresses set forth below:

- 10. <u>Assignment</u>. No party may assign any of the obligations, benefits, or provisions of this Agreement in whole or in part without the expressed written authorization of the other party, which consent may not be unreasonably withheld. Any purported assignment, transfer, pledge or encumbrance made without such prior written authorization will be void.
- 11. <u>Counterparts</u>. This Agreement may be executed in counterparts, each of which will be deemed an original, and all of which will constitute one and the same agreement.
- 12. <u>Governing Law</u>. The terms, covenants and provisions herein will be governed by and construed under the applicable laws of the State of Colorado. For the resolution of any dispute arising hereunder, venue will be in the courts of Boulder County, State of Colorado.
- 13. <u>Headings</u>. All section headings are for convenience or reference only and are not intended to define or limit the scope of any provision of this Agreement.

14. <u>Entire Agreement</u>. This Agreement represents the entire and integrated agreement between the Clerk, the City, and the District with respect to this matter and supersedes all prior negotiations, representations, or agreements, either written or verbal. Any amendments to this Agreement must be in writing and be signed by both parties.

SUMMARY:

The Louisville \$0.25 disposable bag tax went into effect on January 1, 2022 and businesses that provide disposable bags to residents have been required to collect and remit \$0.15 of each tax to the City to be used for sustainability programs and initiatives and costs associated with administering the tax program. Staff has developed a variety of commercial and community waste reduction programs and sustainability staffing to be funded with the collected bag tax revenue. Revenue from the bag tax is projected to decrease beginning in 2024, as plastic bags will be banned statewide on January 1, 2024.

COUNCIL DISCUSSION:

Project Background

In 2020, Louisville voters approved Ballot Question 2A, which aims to reduce single-use bag consumption within the community by applying a \$0.25 tax on every paper and plastic bag provided to customers by Louisville retailers. Retailers will retain \$0.10 of each disposable bag tax collected as a vendor's fee to be used for administration of the tax, such as training staff, improving or altering infrastructure for administration of the tax, and improving infrastructure to increase bag recycling. The remaining \$0.15 of each disposable bag tax collected and remitted to the City shall be used only for costs related to administration of the tax or other sustainability-related initiatives and programs.

Louisville Bag Tax Business Profile


When the tax went into effect, there were 345 total businesses on the bag tax list. Of those businesses, 130 (37.7%) businesses have completed a Retailer Correction Form and are now exempt from the tax, leaving 215 businesses remaining in the bag tax program. New businesses are added to the bag tax business list when they submit for a new business license and, if the business does not use bags, are removed from the list when they complete a Retailer Correction Form and the form is reviewed and approved by City staff.

Of the 215 current bag tax businesses, 72 are food-related (restaurant, bakery, café), 50 are vendors (products, art, catering – may not have a physical location in Louisville), 46 are retail (convenience, hardware, gifts), 40 are service (salon, dentistry, pet

grooming, yoga, etc.), and 7 are grocery and liquor. The percentage breakdown is shown in the graph below.



Revenue and Expenses

As of January 31, 2023, \$188,020.28 has been collected from the disposable bag tax since it went into effect on January 1, 2022. There were \$4,758 in direct expenses related to the bag tax in 2022 (i.e. communication materials). The remaining bag tax revenue is currently \$183,262.28. Prior to adoption of the tax, staff proposed using tax revenue for a variety of purposes, including marketing and training, administration expenses, related programming and low-income resources.

Bag Reduction

The estimated total of single-use bags distributed in Louisville was approximately 4.5 million bags per year before the tax went into effect. Based on bag tax revenue collected, there were 1.25 million (1,253,469) single-use bags distributed in Louisville in 2022, which is a 72% reduction in bag use in comparison to pre-tax estimates. This percentage decrease in bag use is similar to bag reduction seen in other Colorado communities that have implemented bag fees, such as Boulder and Denver. Typically, bag use reduces by 60-80% in the first year and remains consistent in future years of the tax.

Waste Reduction Programs

The objective of the bag tax funded waste reduction programs is to utilize the collected revenue to provide programs and services to the Louisville community that continue to reduce waste in the commercial and residential sectors.

When staff developed the waste programs proposal a variety of options were considered, so that individual businesses are able to choose the program that best suits the needs of the specific business.

Each business participating in the bag tax program will have the option to choose one waste reduction program per calendar year and the estimated value of all waste reduction programs are \$1,000, so that the value of each program option is comparable to the other program options.

A business that is delinquent in bag tax filings will not be eligible for waste reduction programming until they become compliant. Currently, there are 26 businesses (12%) that are delinquent with more than one missing filing. City staff is able to provide support to these businesses to ensure compliance and when compliance is achieved, the business will be eligible for waste reduction programs. New businesses that join the bag tax program in 2023 will be eligible for waste reduction programming in 2024, if the business is in compliance at that time.

If there is funding available, the programs will be offered to all businesses at a value of \$500 per program. This option may become available if communication has been made to all businesses that participate in the program and each business has had an opportunity to participate in one waste reduction program.

Program 1: Bulk Supply of Reusable Bags

Louisville businesses may benefit from a bulk supply of reusable bags. These bags provide support to the business owner and customers by reducing the number of disposable bags used in the community and alleviating the customer from paying the \$0.25 disposable bag tax.

Business sectors this may impact: All – Food, Vendor, Retail, Service, Grocery

Estimated Program 1 Costs

At a \$1,000 program value, each business would receive 500 reusable bags.

Estimated Program 1 Staff Impact

The staff impact of program 1 is medium. Staff will be required to order reusable bags, store bags, communicate with businesses, deliver bags, and track and report program data.

Estimated Program 1 Waste Reduction Impact

The waste reduction impact of program 1 is low. Reusable bags require more materials and energy to make and transport than disposable bags, which means that reusable bags need to be used several times to be more environmentally friendly than paper or plastic bags.

Program 1 Overall Recommendation

Program 1 is a good option for businesses that may not want to participate in more extensive waste reduction programming and would like to provide customers with an alternate option for disposable bags.

Program 2: One Year Subscription to Hard-to-Recycle Pick Up Services

Ridwell is a company that provides residential hard-to-recycle pick up services and has offered to partner with the City of Louisville to provide their services to the Louisville business community through this program. Ridwell will provide businesses with pop up displays that collect plastic film, batteries, light bulbs and threads/clothes. Louisville residents may drop off these items at the collection site(s) and Ridwell will collect these items on a biweekly pickup schedule. As an added benefit, Ridwell is offering each participating businesses a select category for drop off and recycling, which may be tied to the business type (i.e. dog collars at pet store, old books at book store, corks at liquor/wine store). During the program development process, staff will research other regional companies that may provide similar services and will offer all comparable companies equal opportunity to participate as a partner in this program.

Business sectors this may impact: Food, Service, Retail, Grocery

Estimated Program 2 Costs

At a \$1,000 program value, each participating business will receive a one year subscription to this service. At the end of the one year window, the business may opt in to continue the subscription. Ridwell is offering Louisville businesses a 10% discount on monthly service.

Estimated Program 2 Staff Impact

The staff impact of program 2 is low. Staff will be required to communicate with businesses, pay the invoices, and track and report program data.

Estimated Program 2 Waste Reduction Impact

The waste reduction impact of program 2 is high. Both business employees and residents will be able to drop off hard-to-recycle materials year round at commercial locations in Louisville, which will divert these materials from the landfill. Additionally, if Ridwell and the City of Louisville advertise the businesses participating in the program, it will likely increase resident participation in the programs.

Program 2 Overall Recommendation

Program 2 is a good option for businesses that want to take an extra step, but do not want to administer the waste reduction program themselves.

Program 3: Commercial Recycling Incentives

The City of Louisville will work with an existing program through Boulder County Resource Conservation Division (RCD) and Partners for a Clean Environment (PACE) to provide a business with a one-time financial incentive to begin commercial recycling or composting services. Currently, there is no universal recycling or composting ordinance in Louisville and the business community is not required to recycle or compost. Through the Green Business Program, the City of Louisville has received feedback that businesses are interested in commercial recycling and/or interested in a shared recycling bin for a group of geographically close businesses. This program may be attractive to businesses that have a shared area for waste collection and/or are centrally located (downtown, McCaslin).

Boulder County RCD currently provides \$150 coupons for businesses that start commercial recycling programs, so this program would "incentive stack" on the existing program to provide bag tax businesses with a \$1,150 rebate to start services. It should be noted that the RCD program has limited annual funding and is administered on a first come, first served basis.

To redeem the coupon, the business must commit to at least one year or new recycling or composting services or both. Then, the business would contact recycling and composting haulers to receive quotes for services that meet the needs of the business. When the service is finalized, the business completes a form and submits it to the hauler, who submits it to Boulder County. Boulder County reimburses the hauler \$1,150 towards the new service(s). The City of Louisville would work directly with Boulder County to provide the incentive funding.

PACE also provides businesses with up to \$350 worth of recycling and compost bins and signage for their business, so after the service has been set up the business would also be eligible for this funding to support the project.

Business sectors this may impact: Food, Service, Retail, Grocery

Estimated Program 3 Costs

The estimated cost to set up a commercial recycling service is \$125. The estimated monthly service charge for a commercial recycling service is \$130 - \$200/month for weekly pickup service, depending on the size of the container the business requires. This program would cover \$1,150 in costs related to setting up this service for each business, which is approximately 5-8 months of commercial recycling services. Groups of geographically close businesses could select program 3 together to receive a communal recycling bin with more funds allocated from the City.

Estimated Program 3 Staff Impact

The estimated staff impacts would be medium. Staff would be required to work with Boulder County RCD to develop the program and materials, provide support to the business(es) and facilitate conversations with their waste hauling company to decipher the proper bin size and service schedule, coordinate invoicing with RCD and haulers, and track and report program data.

Estimated Program 3 Waste Reduction Impact

The estimated waste reduction impact is high. Businesses that are able to start and sustain commercial recycling programs will continue to divert paper, aluminum and plastics from the landfill even after the initial \$1,150 stipend has been utilized, increasing the commercial diversion rate from the current rate of 24%.

Program 3 Overall Recommendation

Program 3 is a good option for businesses that would benefit from an additional stipend to start a commercial recycling program. With the increasing costs of recycling on the Front Range, the business would need to formulate a plan to cover costs associated with long-term recycling, but this program would supplement costs for approximately six months.

Program 4: Reusable Takeout Restaurant Pilot

DeliverZero is a company that provides reusable takeout programming to Denver and Boulder restaurants and residents. The company is interested in expanding to the City of Louisville with a pilot of 8-12 Louisville restaurants. DeliverZero is integrated into the restaurant's point-of-sale system – when customers place an order, they select DeliverZero as an "add on" menu item and the restaurant staff packs the order into reusable containers. The resident picks up the order (or it is delivered by Door Dash, etc.) and the resident schedules a pickup time for DeliverZero to pick up the containers, clean/sanitize them, and return them to participating restaurants. During the program development process, staff will research other regional companies that may provide similar services and will offer all comparable companies equal opportunity to participate as a partner in this program.

Business sectors this may impact: Food

Estimated Program 4 Costs

The City of Louisville will provide a subsidy for the first 6 months of participation in this program, up to \$1,000 per business. Initial costs include: restaurant recruitment, container purchasing, stocking and cleaning, and customer subsidy. DeliverZero has estimated the cost per business for 6 months of service between \$950 - \$1,000 depending on the number of businesses recruited. Including in the pricing, DeliverZero manages container tracking, returns, and logistics. The company proactively restocks restaurants with reusable containers as needed.

After the first 6 months of City-funded programming, the restaurant and residents incur the costs associated with the program. This includes: customer charge of \$.99/order for order to be packaged in DeliverZero packaging and restaurant charge of \$.25/container if DeliverZero handles dishwashing for restaurant (\$.07/container if the restaurant washes the containers). PACE staff working with Boulder restaurants that utilize DeliverZero have received feedback that the cost is comparable to disposables, especially when restaurants opt to wash the containers in-house.

Estimated Program 4 Staff Impact

The estimated staff impact is medium. City staff would be responsible for developing the program, recruiting businesses, and providing support to interested businesses. DeliverZero has offered to provide on-ground support (included in the proposed cost) in Louisville to help recruit and onboard interested restaurants. DeliverZero has offered to invoice the City of Louisville for 6 months of service per business to keep program administration impacts to a minimum. Staff would also be required to support businesses in transitioning out of the no-cost 6 month pilot. Additionally, staff would be responsible for community outreach and tracking and reporting program data.

It should be noted that the impact to businesses would be high. This program is a paradigm shift for businesses that are used to using disposable materials for takeout orders, so City staff will be responsible for working with the Louisville business community to provide support and guidance to businesses interested in this pilot program.

Estimated Program 4 Waste Reduction Impact

The estimated waste reduction impacts are high. By eliminating disposable serviceware from restaurants in Louisville, the City has an opportunity to change takeout culture and reduce waste and emissions associated with decomposition of disposable serviceware.

Program 4 Overall Recommendation

This is an innovative new program that could be funded through bag tax revenue. If funded, Louisville would become the first suburban community to introduce DeliverZero. As A1 Organics changes policy in regards to compostable serviceware, Boulder County PACE and others are no longer recommending compostable serviceware as an alternative to Styrofoam. Styrofoam will be banned in Colorado starting January 1, 2024 and reusable takeout products are a great solution for restaurants.

Program 5: Zero Waste Grants

"Zero Waste" is a way of rethinking what is done with waste produced and aims for as little landfill waste as possible. Many businesses in Louisville have business-specific needs that may not be best suited by the program options 1-4. If a business would like to take an additional step to consider how they might best utilize an incentive from the City to promote a zero waste environment, the business may submit a concept and

proposed budget to the City for review and approval. If approved, City staff will work with the business to purchase materials or provide incentive funding to support the zero waste project.

Zero Waste Grant project ideas include incentive funding to support:

- Reusable kitchenware (plates, glasses, silverware) for employee kitchens
- Durables for restaurant dining
- Reusable straws, napkins or reusable replacements for other disposables
- Reusable packaging, storage or transport containers
- Commercial dishwashing

Business sectors this may impact: All – Food, Vendor, Retail, Service, Grocery

Estimated Program 5 Costs

City staff will work with businesses to determine which products best support their zero waste goals and businesses will receive up to \$1,000 towards a project that promotes reusable products or reduces waste at the business.

Estimated Program 5 Staff Impact

The staff impact would be high. Staff would be responsible for business communications and outreach, proposal and budget review and collaboration, materials ordering and distribution, and program data tracking and reporting.

Estimated Program 5 Waste Reduction Impact

The waste reduction impact would be high. By funding reusable projects and allowing the flexibility for businesses to determine the most impactful way the City can support their zero waste goals, the City is able to create lasting changes that remove material streams from the landfill and replace them with reusable alternatives, reducing the waste and emissions associated with the decomposition of these materials in the landfill.

Program 5 Overall Recommendation

This program is a great option for a business that is not well suited by the other program options and would like to take an extra step towards waste reduction by removing disposable products and replacing them with reusable products, for either employees or customers or both. The changes made through this grant will be long-term, as well as the effects. Additionally, this program will provide the City with data that illustrates the specific needs from businesses related to zero waste goals.

Low Income Programs & Community Events

Hard-to-recycle events at affordable housing and/or manufactured home communities in Louisville, in collaboration with Eco-Cycle's Center for Hard to Recycle Materials (CHaRM) and Resource Central's Material Reuse facility provide many benefits.

City of Boulder staff administer similar events funded through bag fee revenue and have found them to be very successful. Boulder staff researched barriers for large item recycling in low-to-moderate income (LMI) communities and found that barriers include: no access to a vehicle/way to transport item, physical mobility limitations and recycling costs. By providing the Louisville manufactured home community (Parco Dello Zingaro) and/or the Boulder County Housing Authority Kestrel community with this event, the City would be removing barriers for large item recycling, reducing waste and beautifying the community. CHaRM diverts 25+ types of hard-to-recycle materials from the landfill, including scrap metal, appliances, mattresses, bicycles and glassware. Resource Central's Materials Reuse facility upcycles home fixtures, tools, appliances, furniture and more.

To coordinate this type of event, City staff would work with Eco-Cycle and Resource Central to determine an event date and outreach to the neighborhood would be conducted by city staff and the sustainability advisory board. Residents in the neighborhood would receive a list of items they're able to recycle at the event. Eco-Cycle, Resource Central and City staff would set up drop off locations at a common space in the neighborhood for different types of recyclable items – bicycles, appliances, electronics/cords, mattresses, etc. During the event, residents are able to bring unwanted items to the drop off locations in the neighborhood for recycling. A moving company with a box truck will be available in the neighborhood to assist residents with physical mobility challenges in loading items from inside residences to the drop off locations. Additionally, a trash roll off will be on site for items that cannot be recycled. Materials collected at the event will be recycled at the Center for Hard to Recycle Materials.

After one event, staff will analyze program costs and impact and the program may be replicated in additional neighborhoods or expanded to become a larger community event.

Reusable Bag Giveaway

In addition to the hard-to-recycle community events, reusable bags can be given away at LMI community events, ensuring that community members have access to reusable bags and can avoid paying the disposable bag tax.

Additional Waste Reduction Program Considerations

If approved, sustainability staff will develop each program option by researching partner companies, analyzing waste reduction and greenhouse gas impacts and creating additional program rules, regulations and structure. Staff will develop eligibility requirements for bag tax businesses and create and disperse program brochures and information to eligible businesses. In regards to residential programming, staff will evaluate, develop and expand the community events based on funding capacity and program efficacy.

Waste Reduction Programs Feedback

The waste program proposal was presented to various groups in February and feedback from each group is included below.

Chamber of Commerce

Staff presented the bag tax funded waste reduction programs to the Chamber of Commerce in February. The Chamber recommended the City offer all five waste reduction program options, as each program option appeals to different types of businesses and there is a wide variety of programs. With five options, the Chamber believes there is a greater likely that each business in the program will adopt a program option that fits the business best.

The Chamber also recommends first offering the program options to the businesses currently in the bag tax program and then determining if there are remaining resources to offer programming to the wider business community or allocate remaining funds towards other existing city programs.

More generally, the Chamber recommended offering programs that subsidize costs for businesses and showcasing businesses that participate in city-funded programs as an example for the broader business community.

Sustainability Advisory Board

Staff presented the bag tax funded waste program options to the board at the February 2023 meeting. During public comment, a resident expressed support of the programs and mentioned they would be willing to pay for reusable takeout containers at restaurants.

The board was supportive of the program options and sustainability staffing request. The board recommended researching hard-to-recycle companies to ensure the materials are being recycled properly and also recommended researching the GHG

emissions associated with a reusable takeout program. Regarding the community events, the board recommended setting up rules and restrictions for residents, so staff is able to manage the volume of materials.

The board discussed the ballot language and asked if the bag tax revenue could be used for broader decarbonization efforts, rather than waste reduction. The board supports a prioritization of decarbonization efforts.

The board discussed the longevity of the waste reduction programs and the likelihood for businesses to continue with the programs when the incentive funding is utilized. The board recommended information about how these programs are funded be included in the outreach materials and a short survey be conducted to gather data about long-term program participation, to ensure the funding will not be used only for "pilot programs" but will create long-term waste diversion. The board also recommended program analysis be conducted at the end of 2023, so program improvements and funding reallocation be may considered in 2024, if necessary.

Finance Committee

Staff presented the proposed waste reduction programs and budget to the Finance Committee in February. City Manager Jeff Durbin concluded the presentation with a budget update and request for a new Sustainability staff position. Primary discussion points during the presentation included:

- A need for better bag tax graphical visualizations for bag tax revenue streams
- The desire to reduce waste in the community
- How were proposed incentive amounts determined
- Restrictions surrounding how bag taxes may be used
- The need for community programs and not exclusively commercial programs
- A comparison of other community's reduction of bag use
- The portion of bag taxes that businesses retain
- How sustainability programs will adjust over time to accommodate changes in program participation
- Funding new and ongoing positions via various revenue streams generated through sustainability programs
- Community programs with an emphasis toward moderate-income residents
- Bag tax revenue channeled toward reduced bag reliance programs and program staffing support
- Sustainability is at the top of Council's Work Plan warranting funding availability to be earmarked for staffing

Economic Vitality Committee

Staff presented the proposed waste reduction programs and budget to the Economic Vitality Committee in February. City Manager Jeff Durbin concluded the presentation

with a budget update and request for a new Sustainability staff position. Primary discussion points during the presentation included:

- Funding for POS updates were considered as restaurants have been struggling to find a POS system capable of managing the bag tax
- Support of adding new Sustainability staffing with emphasis on the need for community engagement
- The City can apply for funding to be used for a new position for four years beginning in 2024
- Future needs for multifamily recycling programs
- Supporting data requested to confirm that Ridwell recycles its items, information to be provided in report to Council
- Feedback from the Sustainability Board was summarized noting the impact and effectiveness of the program which may be used for recommendations to the 2024 plan

Public comment feedback and questions include:

- Whether the City expects to end the use of disposable bags leading to the response that a plastic bag ban will take effect statewide beginning in 2024, however paper bags will likely still be used and therefore taxed
- General support of the program noting how the proposed programs will benefit the business community
- Concern regarding businesses who have willingly recycled for a number of years would not receive any compensation for doing so
- Property owners and tenants will need to work together to begin participating in the commercial program
- Questions surrounding fallacy that everything that is purchased can be recycled and questioning if Eco-Cycle or Recycle Colorado have been included in conversations to identify how promoting Ridwell may impact services offered
- Questioning if a City Council will offer representation at a state level to advocate for upcoming composting research bill

Marketing and Outreach

New marketing and outreach will need to be conducted to the Louisville business community to educate them about the waste reduction programs available. General bag tax materials will need to be re-ordered, including reusable bags for the community (available at City Hall) and educational materials for businesses.

Staffing

The City Manager is proposing that funding be allocated towards staff administration to manage the implementation of the new waste reduction programs. A new full-time Sustainability Associate position, partially funded through bag tax revenue, will be responsible for waste programs development and coordination. The new position's job duties will include:

- Waste programming business communications, outreach and education
- Waste program enrollment
- Materials ordering, delivery and distribution to business community
- Program-specific customer service (for Louisville business community)
- · Waste programs data tracking and reporting
- Ongoing bag tax program collaboration including processing Retailer Correction Forms and Materials Requests
- Communication and collaboration with the Finance and Economic Vitality Departments as it relates to the bag tax program, as necessary.

In addition to bag tax revenue, the Sustainability Associate position will partially be funded through the Boulder County Environmental Sustainability Matching Grant funds and will support the work of the Sustainability Division, including but not limited to: the Louisville Green Business Program, municipal sustainability education and engagement, sustainability events and communications.

The staffing support added through the Sustainability Associate will create capacity for the Sustainability Coordinator, who will focus on Council Work Plan policy items, strategic planning around achieving sustainability goals, regional sustainability collaboration, and external grant writing.

Total Proposed Allocation

The budget table on the following page details the actual revenues and expenses related to the bag tax program in 2022 and the estimated revenues and expenses related to the bag tax program and associated waste reduction programs and staffing from 2023 – 2026.

FISCAL IMPACT:

Waste reduction program budget is balanced through Calendar Year 2026 with no anticipated impacts to the City's General Fund. Sustainability and Fiscal staff will monitor Bag Tax Revenue on a quarterly basis.

Project Background



- In 2020, Louisville voters passed ballot question 2A which applied a \$.25 tax on every paper and plastic bag provided to customers by Louisville retailers.
- Retailers retain \$.10 of each tax and remit \$.15 of each tax to the City on a quarterly basis.
- This tax went into effect on January 1, 2022.

Revenue Requirements

Per the ballot language, tax revenue shall be used to pay or reimburse the City for:

- Direct and indirect costs related to tax administration
- Expenses related to sustainability-related initiatives and programs



Bag Tax Business Profile



There are currently 215 businesses on the bag tax business list. When a business applies for a new license, they are added to the list. If the business does not use bags, they may complete a Retailer Correction Form and when that form is reviewed and approved by City staff, the business is removed from the list.


Food (72) – Restaurant, bakery, café, fast food

Vendors (50) – Products, art, catering (may not have a physical location in Louisville)

Retail (46) - Convenience, hardware, gifts

Service (40) – Salon, dentist, pet grooming

Grocery (7) – Includes liquor stores



2022 Bag Tax Revenue and Expenses



As of January 31, 2023, \$188,020.28 had been collected from the bag tax since it went into effect on January 1, 2022.

There was \$4,758 in direct expenses related to the bag tax in 2022.

- Bag tax newspaper advertising
- · Direct business mailers

Remaining bag tax revenue: \$183,262.28

According to pre-ballot City Council communications, the following annual expenses were anticipated:

- Marketing, training and outreach
- Staffing costs related to administration of bag tax and associated programming
- Low-income programming

2022 Bag Reduction



Before the tax, the annual estimate of single-use bags distributed in Louisville was ~4.5 million.

In 2022, there were ~1.25 million single-use bags distributed in the city, which is a **72% reduction** in bag use from pre-tax estimates.

This reduction is similar to reduction percentages seen in other Colorado communities with bag tax/fee programs. Typically, bag use reduces by 60-80% in the first year and remains consistent in future years.



Waste Reduction Programs



3

Objective: Utilize bag tax revenue to provide programs and services to Louisville community that reduce waste in the commercial and residential sectors (5 programs in total).

Overview

- There are a variety of programs business chooses the program that is most beneficial for specific needs
- The value of each program option is \$1,000.
- Businesses that remitted bag tax revenue to the City in 2022 would be eligible for programs (215 total).
 - Delinquent businesses (12% of total) would not be eligible for programs until they become compliant from 2022 filings.
- Businesses that join bag tax program in 2023 would be eligible for programs in 2024.
- If funding is available, programs will be offered to the larger business community at \$500/program value.

Programs were presented to the Louisville Chamber, Sustainability Advisory Board, Finance Committee and Economic Vitality Committee in February.

Program 1: Bulk Supply of Reusable Bags



Objective: A bulk supply of reusable bags provides support to the business owner and customers and reduces the number of disposable bags distributed in the community.



Overall: This is an option for businesses that do not want to participate in more extensive waste reduction programs, but would like an alternative to disposable bags when necessary.

Program 2: One Year Subscription for Hard-to-Recycle Pick Up Services



Objective: A Hard-to-Recycle pickup service allows a business to collect plastic film, batteries, light bulbs, and clothing from employees and residents, which are picked up biweekly – reducing the amount of these items in local landfills.

Overall: This is an option for businesses want to take an extra step towards waste reduction, but do not want to administer the waste reduction program themselves.

Program 3: Commercial Recycling and/or Composting Incentives



Objective: By incentive stacking on an existing Boulder County Resource Conservation Division (RCD) program to provide businesses with recycling and/or composting incentives, the City may increase the commercial diversion rate from its current rate of 24%.



Overall: This is an option for businesses that would benefit from an additional incentive to begin waste diversion services, although businesses would need to formulate a plan to cover costs associated with long-term recycling, as there is a one-year service commitment.

Program 4: Reusable Takeout Restaurant Pilot

Objective: By transitioning restaurants from single-use takeout containers to reusable takeout containers, the City provides businesses with an opportunity to change takeout culture and reduce waste and emissions associated with decomposition of single-use containers.



Overall: This is an innovative new program that could be funded through bag tax revenue. With A1 Organics changes, PACE and others are recommending reusable containers as the best alternative to Styrofoam containers.

Program 5: Zero Waste Grants



Objective: Many businesses in Louisville have business-specific needs that may not be best suited by other program offerings. A business may consider how an incentive from the City can support a zero waste project, submit a proposal and budget, and if approved, receive funding to implement the project.

Project ideas:

- Reusable kitchenware (plates, glasses, silverware) for employee kitchens
- Durables for restaurant dining
- Reusable straws, napkins or reusable replacements for other disposables
- Reusable packaging, storage or transport containers
- · Commercial dishwashing



Overall: This program options offers flexibility for businesses to decide how City funding can best support a transition from disposables to reusables and promote a zero waste environment.

Low-Income Programs & Community Events



Hard-to-recycle events in collaboration with Eco-Cycle and Resource Central provide various benefits.

City of Boulder researched low-to-moderate income resident barriers to large item recycling, which included:

- No access to vehicle/way to transport item
- Physical mobility limitations
- Recycling Costs

By bringing an event to the neighborhood and subsidizing the cost, the City removes barriers, diverts materials from the landfill and beautifies the community.

Staff will analyze the cost and impacts of one event and expand to additional neighborhoods and/or larger community events.

SUBJECT: LOUISVILLE CULTURAL COUNCIL COMMUNITY RESILIENCE

SCULPTURE

SUMMARY:

The Louisville Cultural Council (LCC) began discussing a potential sculpture to commemorate the Marshall Fire in February 2022 – their first board meeting since the fire. Members of the board formed a public art subcommittee, which held meetings in addition to the monthly LCC meetings.

What we've learned through the process of approving this piece of art is that it's important not just to commemorate one event, but to reflect upon and celebrate the enduring resilience of this community. From the economic crash of 2008, to the devastating flood of 2013, the COVID pandemic of 2020, and, ultimately, the fires of 2022, this community has survived and thrived. This piece of art will honor that strength.

After reviewing calls for public art that were posted by other communities in Colorado and across the US, the public art subcommittee wrote a "call for entry" (the art world term for an "RFP"). The call specified that the sculpture would be installed in Louisville's historic downtown area, and that any proposed sculpture needed to be "compatible in style, scale, material, form and content with the historic downtown area".

The call was voted on and approved by the full LCC, and was posted on callforentry.org, the foremost site for calls for entry for public art. The call was additionally promoted through an email sent by callforentry.org, targeting artists in the Colorado region, and was promoted through the City of Louisville's Arts and Events email newsletter. Updates about the sculpture were also shared with a group of representatives that met weekly and that included representatives from the City of Louisville, City Council, Louisville Rising, Marshall ROC, and Boulder County. In response to the call, sixteen entries were received, including artists from Boulder County, the western region of the US, and one international entry. The entries showed a diversity of materials and styles.

The public art subcommittee consulted with Suzanne Janssen, the City of Loveland's current Public Art Manager of Cultural Services, and Louisville's former Cultural Arts and Special Events Coordinator. During an extensive meeting with Janssen, she outlined the process that the City of Loveland uses to find jurors for their public art sculpture competitions.

Following her recommendations, the public art subcommittee invited a wide variety of Louisville's community members that fulfill the following categories: fire survivors, therapists, prominent members of the community, business owners, "everyday" people, artists, BIPOC individuals, and members of LCC. Some people who were invited accepted, some declined, and some recommended other members of the community who were then contacted to serve on the jury. In total, 14 volunteers agreed to jury the public art submissions to determine the winning entry.

The piece titled "Community Resilience" was the overwhelming winner selected by the jury. This piece includes themes of rebuilding and hope. The sculpture is a cross section of a house, with a metal bird's nest and birds on top. The sculpture is covered with ceramic tiles; each tile will represent one house that was lost in the fire, with the homeowners being invited to paint their house number on the tiles and to participate in showing their hope to return to their homes once they are rebuilt.

Following selection of this sculpture, the public art subcommittee walked Main Street to evaluate potential sites within the specified historic Downtown area where the art could be installed. Two top locations were selected that would allow a large number of people to see and engage with the sculpture – outside of City Hall and in Memory Square Park. Public notice signs were placed in each of these locations.

There were no objections received during the public comment period. The LCC reviewed this, and voted to recommend the "Community Resilience" sculpture and City Hall location to City Council for final approval. The location was chosen based on its visibility, as residents and visitors can see the sculpture, engage with it, and celebrate and honor the resilience and strength of the community.

FISCAL IMPACT:

\$22,000, budgeted for Public Art

PROGRAM/SUB-PROGRAM IMPACT:

Providing public art that continues to follow the Public Art Policy, while also reflecting upon the resilient spirit of the community.

RECOMMENDATION:

Approve the "Community Resilience" sculpture.





SUMMARY:

On November 8, 2022 the electors of the State of Colorado passed Proposition 125 which converted current Fermented Malt Beverage (Off-premises) Liquor License holders to Fermented Malt Beverage and Wine Retailer Liquor License. This new license type, effective March 1, 2023, will allow these licensees to conduct tastings in their establishments (grocery stores, convenience stores and liquor licensed drugstores).

After reviewing the Louisville Municipal Code staff determined the code needs to be amended to allow for tastings for the new license types as it currently only allows tastings at Retail Liquor Stores. The attached ordinance amends the code to do this.

The Local Licensing Authority (LLA) reviewed the proposed changes during their January 23, 2023 meeting and recommends updating the code to allow tastings for the additional licensee types.

Staff also determined the Louisville Municipal Code is currently more restrictive than State statute regarding the rules for conducting tastings. When the code was first adopted in 2004, the City followed the State guidelines. However, State guidelines were subsequently changed, but the City's guidelines did not follow suit. The differences are noted below.

Regulation	City Rule	State Rule
Tasting Hours	Between 11am and 7pm only	Between 11am and 9pm only
Limit of Days per Year	A limit of 104 days per year and no more than four of the six days from Monday to Saturday	No more than 156 days per year

ORDINANCE NO. 1852 SERIES 2023

AN ORDINANCE AMENDING CHAPTER 5.08 OF THE LOUISVILLE MUNICIPAL CODE CONCERNING LIQUOR TASTINGS

WHEREAS, City Council previously adopted Section 5.08.075 of the Louisville Municipal Code authorizing retail liquor stores to conduct liquor tastings under certain circumstances; and

WHEREAS, since that time, the Colorado Liquor Code has been amended to allow additional licensees, including liquor licensed drugstores and fermented malt beverage and wine retailers, to conduct liquor tastings; and

WHEREAS, City Council desires to amend Section 5.08.075 to reflect these amendments to the Colorado Liquor Code.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOUISVILLE, COLORADO:

<u>Section 1.</u> Section 5.08.075 of the Louisville Municipal Code is hereby amended to read as follows (words to be added are <u>underlined</u>; words to be deleted are <u>stricken through</u>):

Sec. 5.08.075. Liquor tastings.

- A. The city hereby authorizes tastings to be conducted by retail liquor store licensees, liquor licensed drugstores, and fermented malt beverage and wine retailers in accordance with this section and pursuant to section 44-3-301, C.R.S. Within the city, it is unlawful for any person or licensee to conduct tastings unless a permit has been obtained in accordance with this section. The local licensing authority is authorized to issue tasting permits in accordance with the requirements of this section.
- B. A retail liquor store licensee that wishes to conduct tastings shall submit an application for a tastings permit to the local licensing authority annually. The local licensing authority may reject the permit application if the applicant fails to establish that the licensee is able to conduct tastings without violating the provisions of this section or creating a public safety risk to the neighborhood. The local licensing authority shall establish application procedures for tastings permits.
 - C. Tastings shall be subject to the following limitations:
 - 1. Tastings shall be conducted only by a person who has completed a server training program that meets the standards

established by the Liquor Enforcement Division of the Colorado Department of Revenue and who is a retail liquor store licensee, or an employee of a licensee, and only on a licensee's licensed premises.

- 2. The alcohol used in tastings shall be purchased through a licensed wholesaler, licensed brew pub, licensed distillery pub or winery licensed pursuant to section 44-3-403, C.R.S., at a cost that is not less than the laid in cost of such alcohol. Such suppliers shall have licenses from the city to the extent required by this section and section 44-3-301, C.R.S.
- 3. The size of an individual alcohol sample shall not exceed one ounce of malt or vinous liquor or one-half of one ounce of spirituous liquor.
- 4. Tastings shall not exceed a total of five hours in duration per day, which need not be consecutive.
- 5. Tastings shall be conducted only during the operating hours in which the licensee on whose premises the tastings occur is permitted to sell alcohol beverages, and in no case earlier than 11:00 a.m. or later than 7:00 p.m.
- 6. The licensee shall prohibit patrons from leaving the licensed premises with an unconsumed sample.
- 7. The licensee shall promptly remove all open and unconsumed alcohol beverage samples from the licensed premises or shall destroy the samples immediately following the completion of the tasting.
- 8. The licensee shall not serve a person who is under 21 years of age or who is visibly intoxicated.
- 9. The licensee shall not serve more than four individual samples to a patron during a tasting.
- 10. Alcohol samples shall be in open containers and shall be provided to a patron free of charge.
- 11. Tastings may occur on no more than four of the six days from a Monday to the following Saturday, not to exceed 104 days per year.

- 12. No manufacturer of spirituous or vinous liquors shall induce a licensee through free goods or financial or in-kind assistance to favor the manufacturer's products being sampled at a tasting. The licensee shall bear the financial and all other responsibility for a tasting.
- 13. The applicant for a tastings permit shall certify on the application that all persons serving alcohol at tastings have completed a server training program that meets the standards established by the Liquor Enforcement Division of the Colorado Department of Revenue.
- D. A violation of a limitation specified in this section or of section 44-3-301(10) or section 44-3-901, C.R.S., by a retail liquor store licensee, whether by the licensee, the licensee's employees or agents, or otherwise shall be the responsibility of the retail liquor store licensee who is conducting the tasting.
- E. A retail liquor store licensee conducting a tasting shall be subject to the same revocation, suspension, and enforcement provisions as otherwise apply to the licensee and are imposed by the local licensing authority. The local licensing authority shall conduct a hearing with regard to any violations of this section in accordance with the requirements of this Code, the authority's bylaws and rules of procedure, and section 44-3-601, C.R.S.
- **Section 2.** If any portion of this ordinance is held to be invalid for any reason, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council hereby declares it would have passed and approved this ordinance and each part hereof irrespective of the fact that any one part be declared invalid.
- **Section 3.** The repeal or modification of any provision of the Municipal Code of the City of Louisville by this ordinance shall not release, extinguish, alter, modify, or change in whole or in part any penalty, forfeiture, or liability, either civil or criminal, which shall have been incurred under such provision, and each provision shall be treated and held as still remaining in force for the purpose of sustaining any and all proper actions, suits, proceedings, and prosecutions for the enforcement of the penalty, forfeiture, or liability, as well as for the purpose of sustaining any judgment, decree, or order which can or may be rendered, entered, or made in such actions, suits, proceedings, or prosecutions.
- <u>Section 4.</u> All other ordinances or portions thereof inconsistent or conflicting with this ordinance or any portion hereof are hereby repealed to the extent of such inconsistency or conflict.
