Call to Order – Mayor Maloney called the meeting to order at 6:01 pm.

Approval of Agenda – The agenda was approved by all members.

Approval of Meeting Minutes – Moshak moved to approve the minutes, Harford seconded the motion. The minutes from the March 13 meeting were approved as written.

Ember Brignull, Open Space Superintendent

Ginger Cross, Marketing Specialist Ryder Bailey, Finance Director

Brignull reviewed the land classifications for open space properties: Preserve, Protect, Visitor, and Other and reviewed the map of the properties as classified in 2003. She noted the goals of the classifications is to be consistent with good stewardship and sound ecological principals. Additionally, the City tries to balance land preservation with recreation. Parcels that have not yet been classified will be included with the next update to the PROST master plan in 2024. There are a number of parcels that still need to be classified.

Director Bailey reviewed the 7-year trends for Parks and OS operations and acquisition and capital.

Mayor Maloney noticed the increase in parks costs appears to be outpacing spending in open space. Members agreed that is something that needs to be explained to voters.

Mayor Maloney noted that in 2021 Council allocated additional General Fund money to pay to boost parks maintenance. We need to be able to explain that to voters. He would like to see an asset management program in place for both programs so we don't defer maintenance.

Mayor Maloney noted that if the tax does not pass there will need to be discussions of what to close or the impacts will be. City Manager Durbin added that this may not be the time to ask for more in this ballot issue because if this doesn't pass the impacts are severe.

Cross reviewed an outline of communications planned for the PROST Department for the remainder of the year. Part of it is dedicated to educating the public about properties and teaching about open space properties and parks. It will include a social media campaign.

Mayor Maloney stated staff is working on a polling contract. Once the pollster in on board the questions will need to be determined.

Durbin reported that staff had a conversation with staff from Colorado Springs about their recently failed ballot issue. Bailey noted the ballot question did ask to double the tax level and was very long. It may have overwhelmed the voters. Colorado Springs is going back at their April 4 election with a shorter question that does not ask to increase the rate but extends the tax for 20 years.

Public Comments - None

Moshak noted she had supplied some information in the packet about ballot measures around the state.

Mayor Pro Tem Fahey stated that this year we may want to just ask for an extension of the tax with no increase. She said perhaps ask to keep the tax in perpetuity, but not ask for more a higher level of taxation.

Moshak reviewed the tax rates for the surrounding communities and some history.

Mayor Maloney stated that it makes sense to consider asking for approval of the tax in perpetuity. We don't want to double it but may want to consider some increase.

Mayor Maloney stated the April meeting will be used for the group to brainstorm on what we might want to consider so that information can be taken to the polling company to see if there is community support.

Adjourn – The meeting adjourned at 7:40 pm.

SHALL CITY TAXES BE INCREASED \$11,134,000 ANNUALLY BEGINNING JANUARY 1, 2022, AND BY WHATEVER AMOUNTS ARE RAISED IN YEARS THEREAFTER, BY INCREASING THE RATE OF SALES AND USE TAX DEDICATED TO TRAILS, OPEN SPACE AND PARKS (TOPS) FROM ITS CURRENT RATE OF .1% (ONE TENTH OF A CENT), OR ONE (1) PENNY ON EVERY TEN (10) DOLLAR PURCHASE, TO .2% (TWO TENTHS OF A CENT), OR TWO (2) CENTS ON EVERY TEN (10) DOLLAR PURCHASE, FOOD, AND OTHER PURCHASES EXEMPTED FROM SALES TAX, WITHOUT CHANGING THE PURPOSES WHICH INCLUDE:

• PRESERVING FRAGILE ECOSYSTEMS, NATURAL AREAS, SCENIC VISTAS AND AREAS, FISH AND WILDLIFE HABITATS AND CORRIDORS, AND IMPORTANT AREAS THAT SUPPORT BIODIVERSITY, NATURAL RESOURCES AND LANDMARKS;

• CONSERVING NATURAL RESOURCES SUCH AS WATER AQUIFER RECHARGE AREAS, SURFACE WATER, AND FOREST LANDS;

• ACQUIRING, DEVELOPING AND MAINTAINING OPEN SPACE LANDS AND TRAILS; AND

• ACQUIRING, DEVELOPING AND MAINTAINING PARKS;

WITH ALL EXPENDITURES BASED ON RECOMMENDATIONS OF AN ADVISORY COMMITTEE AND SUBJECT TO INDEPENDENT AUDIT: WITH NO MORE THAN FIVE PERCENT (5%) OF REVENUES DERIVED TO BE USED FOR ADMINISTRATION, PLANNING AND PROGRAM MANAGEMENT, AND NO MORE THAN TWENTY-FIVE PERCENT (25%) FOR MAINTENANCE AND OPERATIONS OF ALL CITY PARKS. TRAILS AND OPEN SPACE LANDS, AND THE REMAINING REVENUE DIVIDED INTO FORTY PERCENT (40%) USED FOR ACQUISITION, DEVELOPMENT AND MAINTENANCE OF ALL PARKS, THIRTY PERCENT (30%) FOR ACQUISITION, DEVELOPMENT AND MAINTENANCE OF ALL TRAILS, AND THIRTY PERCENT (30%) FOR ACQUISITION, DEVELOPMENT AND MAINTENANCE OF ALL OPEN SPACE LANDS, REGARDLESS OF HOW ACQUIRED; AND WITH THE INTENT OF THE VOTERS THAT MONIES DERIVED FROM THE INCREASE SHOULD NOT OFFSET ANY EXPENDITURES FROM THE GENERAL FUND; AND EXTENDING THE EXPIRATION OF THE TOPS SALES AND USE TAX TO AND UNTIL DECEMBER 31, 2041: THE ABOVE CONSTITUTING A VOTER-APPROVED REVENUE CHANGE AND EXCEPTION TO ANY CONSTITUTIONAL, STATUTORY AND CHARTER REVENUE AND SPENDING LIMITATIONS THAT MAY OTHERWISE APPLY?

WITHOUT IMPOSING ANY NEW TAX OR INCREASING THE RATE OF ANY EXISTING TAX, SHALL THE EXISTING 0.1% (ONE TENTH OF A CENT) CITY SALES AND USE TAX FOR TRAILS, OPEN SPACE AND PARKS (TOPS) BE EXTENDED FROM ITS CURRENT EXPIRATION OF DECEMBER 31, 2025 THROUGH DECEMBER 31, 2045, WITH THE SAME USES FOR OPEN SPACE ACQUISITION AND STEWARDSHIP, AND TRAILS AND PARKS ACQUISITION AND MAINTENANCE, THE ABOVE CONSTITUTING NO CHANGES TO THE PROGRAM EXCEPT ALLOWING FUNDS DEDICATED TO MAINTENANCE OF TRAILS AND OPEN SPACES TO BE USED REGARDLESS OF HOW THE TRAIL OR OPEN SPACE WAS ACQUIRED, AND IN THE OPEN SPACE CATEGORY A MINIMUM OF SEVENTY-FIVE PERCENT (75%) OF FUNDS BE SPENT ON ACQUISITION OF OPEN SPACE, AS A CONTINUATION OF A VOTER-APPROVED REVENUE CHANGE AND EXCEPTION TO ANY CONSTITUTIONAL, STATUTORY, AND CHARTER REVENUE AND SPENDING LIMITATIONS THAT MAY OTHERWISE APPLY?
