SUBJECT: LIQUOR LICENSE FEES

SUMMARY:

The City of Louisville reviews and establishes fees annually, including fees for liquor licensing. Prior to proposed fees going to City Council in November, the Licensing Authority is being asked to review the fees the City currently charges versus those allowed by the State and charged by other municipalities.

For example, the City of Louisville currently charges \$131.00 to renew a Hotel & Restaurant Liquor License. This charge constitutes an application fee of \$56.00 and a license fee of \$75.00.

At the time of their last revision on May 31, 2023, the local renewal application fee set by the State is \$100.00 and the license fee is \$75.00 for a total of \$175.00

The surrounding municipalities of Lafayette, Erie, Boulder, and Broomfield all charge \$175.00 to renew a Hotel & Restaurant Liquor License. (I did not receive a response from Superior and their fees are not listed on the city website.)

Attached is the State Fee Schedule of May 31, 2023 and the current City of Louisville Fee schedule for comparison.
