

As our community continues to recover from the Marshall Fire and Straight Line Wind Event, the City is prioritizing efforts to mitigate risk and build resiliency for future disasters. Below is a summary of where we're at on the road to recovery and what our priorities and resources are as we work to create a better prepared, more resilient community.

REBUILDING THE HOMES & BUSINESSES WE LOST

- ▶ 566 properties participated in coordinated private property debris removal in Louisville, Superior, and Boulder County with work completed within 4 months
- Over 60% of <u>rebuilding permits</u> have now been issued
- ► A majority of homes are being rebuilt to higher energy-efficiency standards (approx. **66%** in Louisville)

BY THE NUMBERS:

THE FINANCIAL IMPACT

- ► Total estimated loss of \$2 billion across Louisville, Superior, and Boulder County
- Coordinated private property debris removal estimated at \$30 million with Louisville's share at \$13.5 million
- City repairs estimated at \$10 million
 - ▶ \$4 million in damage to buildings & infrastructure
 - ▶ \$6 million in damage to concrete & asphalt
- City business income loss estimated at \$1.9 million
- ▶ \$3.7 million in FEMA public assistance approved
- **\$2.7 million** in City insurance proceeds approved
- ► City has processed **\$4 million** through the Use Tax Credit Program

BY THE NUMBERS:

PUBLIC RESOURCES ALLOCATED

State of Colorado Disaster Preparedness & Recovery Resources (Senate Bill 22-206):

- \$12 million for rebuilding home loans & wind/wildfire protection loans
- ▶ \$12 million for housing rehabilitation/reconstruction, rental assistance, and wind and wildfire protection
- ▶ \$6 million for housing recovery
- ▶ \$500K for infrastructure mitigation and \$600K for resiliency planning to be split between Louisville, Superior, and Boulder County

Boulder County Funding:

▶ \$11 million from Ballot Measure 1A (Wildfire Mitigation) approved at November 8, 2022 general election



DISASTER MITIGATION: BUILDING A MORE RESILIENT LOUISVILLE

- ► Applying to FEMA for **\$4 million** to install and upgrade generators at critical facilities
- Awarded \$90,000 from the Colorado Department of Local Affairs to hire a Recovery & Resilience Manager
- Awarded \$290,000 from Colorado State Forest Service for fuels reduction treatment on public land and development of mitigation program
- Completed additional mowing on City-owned land and regenerative grazing and ditch clearing to reduce wildfire fuels is in process
- Development of Wildfire Risk Assessment to examine risks of City-owned land and opportunities for mitigation is underway
- ► Updated Louisville <u>Hazard Mitigation Plan</u> and actions to reduce future risk
- Update to Boulder <u>Community Wildfire Protection</u> <u>Plan</u> (CWPP) is in process

DISASTER PREPAREDNESS: LEARNING AND IMPROVING

- City is developing an Emergency Improvement Plan to enhance planning and operations for future disasters
- ► The ongoing <u>Disaster Education & Outreach Series</u> is designed to help mitigate risk and build resiliency across our community
- Completed <u>emergency alert system upgrades</u> including development of pre-determined zones and communications to encourage sign-up
- City participated in First Responder Community Emergency Summit to discuss lessons learned from the Marshall Fire
- City participated in <u>Boulder County After Action</u> <u>Report</u> and <u>subsequent updates</u> to review lessons learned and action steps for improvement
- City participated in <u>State Facilitated Learning</u>
 <u>Analysis</u> to learn about fire behavior during the
 Marshall Fire and the response
- City participated with Urban Land Institute (ULI) on an <u>Advisory Service Panel</u> to explore Wildland Urban Interface (WUI) best practices and recommendations

MENTAL HEALTH RESOURCES

As our community continues to recover from this trauma, **please remember** how important it is to recognize your emotional needs and take care of yourself and those around you.

Researchers have found that it can take 24 to 60 months for a community to move through the phases of disaster response. The healing journey is a unique experience, and one that each person processes differently.

Individual and Family Counseling

Jewish Family Service (JFS) and Community Foundation Boulder County (CFBC) have partnered to offer counseling services to Boulder County residents affected by the Marshall Fire. The program offers impacted individuals or families ten free counseling sessions. Visit JewishFamilyService.org/bcc.
