Terminology

- All Ages and Abilities 8 years (3rd Grade) old to 80 years old
- 85th Percentile Speed The speed at which or below 85 percent of drivers are traveling.
- Average Daily Traffic (ADT) Average amount of traffic on a street each day.



Colorado Traffic Law (CRS 42-4-802)

 (1) When traffic control signals are not in place or not in operation, the driver of a vehicle shall yield the right-of-way, slowing down or stopping if need be to so yield, to a pedestrian crossing the roadway within a crosswalk when the pedestrian is upon the half of the roadway upon which the vehicle is traveling or when the pedestrian is approaching so closely from the opposite half of the roadway as to be in danger.

City Expectation: Drivers stop and wait at crosswalks when pedestrians are present and show intent.

 (3) A pedestrian shall not suddenly leave a curb or other place of safety and ride a bicycle, electrical assisted bicycle, or electric scooter, or walk or run into the path of a moving vehicle that is so close as to constitute an immediate hazard.

City Expectation: Pedestrians and Bicyclists be prepared to stop at all crossings.

- Street Light Data (Cell Phone Data)
- In Years of Accident Data (No Trend or Pattern within Corridor)
- Reviewed All Intersection Vision Clearance Areas in Accordance with City Code




Traffic Calming Considerations

- Volume of Traffic and Road Classification (ADT)
- Posted Speed vs 85th Percentile (Survey)
- School, Regional Trail, Vulnerable Community, Other Factors
- Context of Road Uses Residential, Commercial, Industrial
- Residential On Street Parking
- Police and Fire Delay/Response Times



Road Classification

Classification	Average Daily Traffic (Vehicles)
Arterial	5,000 - 30,000
Collector	1,500 - 5,000
Local	0 - 1,500
Industrial	0 - 1,500


City might consider mitigation at 3 mph over.

Law Enforcement may ticket 5 mph and over.






Fireside Elementary Attendance Area






Streetlight Data

- The highest cut through timeframe is 7am-8am and 3pm-6pm.

Survey open for 3 weeks.


 QR Code Signs provided near school and trail crossings for 2 weeks.



The Posted Speed Limit is 25mph






70% Believe There is a Speeding Problem IF YES, HOW SEVERE IS THE PROBLEM? (5 - VERY BAD)








Most People Believe Cut Thru and Residents are the Problem 63% Believe Peds and Bikes **Practice Safe Habits**
