September 2023 Louisville Cultural Council Staff Report – Erica Schmitt

#### Arts and Events Updates – Items Outside of the Cultural Council:

**"Street Faire"** came to an end on August 11. Despite some rainy evenings, the season was a success – especially Dumpstaphunk, Shakedown Street, and The Petty Nicks Experience. It can be a challenge to find the "Goldilocks" bands for an event like Street Faire, with enough bands having name recognition, but not being so large as to cause safety logistics or public nuisance complaints, and we commend Street Faire for their efforts to find bands that are a good fit for the city. On 09/05/23, City Council approved the 2024/2025/2026 Street Faire contract, and on 09/12/23, the Street Faire Committee set the 2024 concert dates.

The **Labor Day** and **Fall Festival** celebrations were a great success this year. The weekend started with a Friday night Senior Dinner, providing free food, live music, and raffle prizes to over 150 local seniors. Over 1,200 individuals marched, walked, danced, or rode in the 87<sup>th</sup> Annual Labor Day Parade, and over 80 pets participated in the Children's Pet Parade. The Fall Festival hosted a free petting zoo, live music from an Irish bluegrass band, 31 local vendors (handmade goods, locally made foods, and a few nonprofits – no mass-produced goods or commercial services among the vendors), and eight food trucks.

We still have a smattering of venues rentals during this time of year. In August and the first two weeks of September, Steinbaugh Pavilion hosted a wedding and the Library's "Afternoon of Cultural Dance." The Louisville Center for the Arts was mostly unavailable for rentals due to CenterStage Theater Company's summer camp (through (Aug. 11), Coal Creek Theater rehearsals and performances, and the Louisville Art Association's annual show.

The Louisville **"Farmers Market**" has a few weeks left of its 15<sup>th</sup> season, and closes on Saturday, Oct. 14, 2023. The market has booked musicians to perform every Saturday this season. They also work with high school musicians, strategically placing the musicians in sections of the market that receive less foot traffic. The high school musicians play for tips; the main musicians are paid by the market.

The Farmers Market has different local farms and products each week. To help increase the availability of fresh produce for all, they accept EBT (SNAP or "food stamps"), and participate in the "Double Up Food Bucks Colorado" program, which matches whatever someone spends (up to \$20 per visit), helping food benefits go even further. The day after the Farmers Market concludes, the ice rink moves into Steinbaugh Pavilion.

When the 2022-23 ice skating season concluded, the City was informed that the rink operators would not be renewing their contract. Erica spent the spring researching ice rinks and connecting with other cities, hotels, and shopping centers that had outdoor ice rinks. She received quotes from several vendors who would be capable of running the Louisville ice rink, and brought the information to the City's Economic Vitality Manager, who secured a contract and funding for the 2023-24 season.

The rink's former name, "WinterSkate" was trademarked by a former operator, and cannot be used. This winter, the brand new ice rink will reopen with a new name that was voted on by Downtown Business Association Members and City staff: "**The Ice on Front**." We are excited by the responsiveness and quality the new ice rink operators have already demonstrated, and look forward to a great season.

#### Art Grants:

# Updates on the previous cycle of art grants. Per the 2023 Art Grant Agreement, projects must be completed between March 1, 2023 and July 31, 2024.

- Ambient Experience concluded on June 11, 2023.
- Soul Penny Circus concluded on June 17, 2023.
  - Evaluation form has been requested repeatedly.
  - Check for \$500 (final 25% of grant funds) will be sent upon receipt of evaluation form.
- "Not All Men" songwriting workshops and performance showcase series for women, LGBTQ+, and gender-diverse folks concluded on August 13, 2023.
  - Eval has been requested.
  - Check for \$47.50 (final 25% of grant funds) to be sent upon receipt of evaluation form.
- Motus Theater is confirmed for Saturday, Sept. 30, 2023 at the Arts Center.
- Celebrate EDU wants at least one week of gallery space, which isn't possible with the current demands of resident arts groups. Erica is working with the Library to see if Celebrate EDU could exhibit in the Library gallery for one month in 2024. Aiming for early 2024 project completion.

#### Public Art:

"Community Resilience" by artists Rita Vali and Arabella Tattershall (City Hall sculpture)

- Structural engineer provided stamped plans for a structurally sound base. City received these plans on 09/08/23, and has given the artists the go-ahead to begin working on installing a base.
- Artists will be setting up boxes at the Library and Rec. Center to collect community words about "resilience". Flyer draft for receiving entries received 09/13/23.
- Per contract, artists have received 50% of the total payment, and will receive the remaining \$11,000 upon the City's acceptance of the sculpture.

"Heart of the Community" by artist Darla Okada (Library Plaza mural)

- The Library hosted a small event on August 27 with freeze pops to celebrate the new Plaza and the upcoming completion of the murals.
- Continued weather delays expected completion in late September, 2023.
- Per contract, artist has received 50% of the total payment, and will receive the remaining \$5,000 upon the City's acceptance of the mural.

"South Street Sculpture" by artist Greg Fields (South Street pedestrian underpass)

- Requested carryover of LRC funds
- Sculpture placement is not confirmed. Sharon has weekly calls with the railroad insurance company, and is working on:
  - Railroad protective liability insurance
  - Adjustment of the City's lease
- Sharon has received information about how much the rail road liability insurance and lease would cost (approx. \$1,200 upfront), but has not received a contract or invoice.
- Sharon has updated the artist about this progress; the sculptor has not started on this piece yet.
- The sculpture still needs to go through public notice, an LCC vote, and City Council approval.

#### Art Repairs and Maintenance:

The "Melody" sculpture and "Sky Sculpture" were repaired in July, 2023. "Melody" suffered vandalism from someone using a tool like a "Sawzall" to try to cut through her foot. The "Sky Sculpture" needed shims to be installed at its base to reduce rocking motion of the piece.

The cost of repairs did not meet the art insurance deductible threshold, and the City did not submit a claim to our insurer. Erica will be reviewing the list of public art and their insurance values in September as part of the annual review of scheduled items coverage.

The yearly cleaning and wax conditioning of outdoor bronze sculptures was completed in July, 2023.

#### Louisville Cultural Council Planning – Venue Reservations for 2024:

As a reminder, the resident arts groups (Louisville Art Association, CenterStage Theater Company, Coal Creek Theater Company) meet in early autumn to claim the dates that they will be using the Louisville Center for the Arts in the upcoming calendar year.

The LAA has already submitted the 2024 dates, and the theater companies are expected to submit their dates soon. The Louisville Cultural Council is encouraged to consider reserving dates for the upcoming cycle of **Art Grants** ASAP. Kindly note that grant recipients appreciate being able to use the venue for the entire day, and that Fridays, Saturdays, and Sundays are preferred. Whenever possible, please consider reserving an additional half or full day prior for groups that would like to be able to test the venue technology, rehearse in the space, or begin setting up an art show in advance.

The LCC dates for 2024 "Summer Concerts in the Park" will be submitted to the Parks department as soon as they can accept 2024 dates. The Permitting department will also be made aware of these dates.

In response to local artists experiencing harassment about their art, and the tragedy at the Club Q venue in Colorado Springs, the Boulder Arts Commission recently unanimously approved a statement of principle:

The Boulder Arts Commission is aware that artists in our local community have been bullied and had their artwork defaced. We believe in and work to support the following tenets of a thriving arts environment:

- Protection of freedom of expression,
- Acknowledging a variety of perspectives from the community while still honoring our Statement on Cultural Equity, and
- That the fabric of expression that we all weave makes us a stronger and more vibrant community when it includes diversity of expression.

These tenets form the cornerstones of the City of Boulder's Cultural Plan.

The Boulder Arts Commission stands with our artists from all backgrounds including, but not limited to, the LGBTQ+, immigrant, PIPOC, Indigenous, Latine, disability, unhoused, faith-based, and other communities. If you find yourself, your organization, or your art as the target of harassment, bullying, or threats, these are resources to help you.

At our next summit of cultural nonprofit leadership, we will meet these challenges of intolerance and harassment head on. Our panel, including Z of Bread and Roses Law and artist/survivor Wyatt Kent, will talk about the best ways to protect yourselves and your community against harassment, offer resources should you run into challenges, and help us band together as a community against these forces with the courage necessary for great art to flourish. # LCC Chair Report August 17, 2023

- Summer concert series Once again, the LCC successfully hosted five concerts at Community Park. Even though the LCC has just 3 members, the council was able to provide a great experience for the citizens of Louisville Colorado. The weather didn't always cooperate; however, I still see the summer concerts in the park series as a success for 2023. We will begin scheduling the concerts for 2024 this fall.
- 2. The LCC had the opportunity to collaborate with the Cultural Caravan. The collaboration had what I thought were mixed results. The Concert at Fire Station No. 1 was a highlight of the summer LCC events. The concert in the park with Zimbria was successful, but I question what the benefit was for the City. I would not hold the Pop-Up again. We will discuss future collaborations.
- 3. The LCC continues to be woefully understaffed with just 3 volunteer members on what should be an 8-10 person council. We started the year with 8 members. It has been 5+ months now with a 3 person council. W
  - a. We have been working with just 3 volunteer members for several months now and frankly we needed more help for the Summer Concerts in the Park series. I personally devoted a minimum 5 hours for each of the 4 events I supported. We needed more support from the City. Tasks at the Summer Concerts include greeting sound engineers and ensuring they have what they need. Greet the bands and welcome them to our city and Summer Concerts. Cold water should be provided for the bands and sound people (I personally have purchased and provided bottled water the past 2 summers. The drinking fountains were inoperable at 2 of the events.) Someone needs to present to coordinate where food trucks are located. Beth has done this for the past 2 summers. A level of parking control is needed (block entry lane, mark disabled parking spots and inform people that they cannot park unless they are members of the band or sound team). The LCC easy-up needs to be setup to provide a contact point for lost and found and citizen questions. The city should provide chairs for the support staff.
  - b. Fall event planning has been primarily fallen on the LCC chair for most events. I will delegate more moving forward; however, with just 3 volunteer members this is not a simple task. How will we manage the Public Art Grant process? That process consumed multiple members time in 2022. How will we manage with just 3 volunteers? It is simply too much for the current Council members. We cannot have a viable selection process with just 3 volunteer members.
  - c. What are the City's plans to address the current situation? It is extremely frustrating to have asked for and received an increased budget and then not have the resources to execute a better plan with that budget. What should we expect from the City? One example: I personally asked who should schedule the Concerts on the Plaza, which was a good idea proposed by city staff, and was told that the LCC is responsible. I accept that, however, please remember this council is a woefully understaffed group of volunteers. I sometimes feel like the City has abandoned the LCC.

3. Establish a center of excellence for ambient music in Boulder County with live performances and future educational events (for example "artist talks").

#### Our artist statement:

The term "Ambient" music was first coined by English musician Brian Eno, who describes it as "an atmosphere, a tint...designed to induce calm and space to think". Today, Ambient music is a diverse sub-genre of music in general and electronic music specifically. Ambient music creates landscapes of natural and artificial sounds generated and processed with analog and digital equipment. It is the goal of this project to combine live performances of Ambient electronic music with components of visual art to create an immersive Ambient Experience.

#### Please describe the impact your event had on the community:

#### Numbers of individuals reached:

The event had 36 attendees for the performances at the Louisville Center for the Arts.

The video of the performances will be uploaded to YouTube once editing is complete and based on previous experience (from 2021) we expect to reach ~1000 more individuals with the video on YouTube. The target release date for the 2023 performance video is October 2023.

#### How did you attract your target audience?

We primarily used online promotion on social media (Facebook, Instagram) and our website. We posted in local Louisville Facebook groups (incl. Neighborhood-specific groups) and music-specific groups (Louisvilla and Lafayette area music communities), and the Louisville Cultural Council also posted about the event on their Facebook page. Additionally, the artists posted on their individual social media pages (Facebook, Instagram, etc).

#### Did the activity generate any unexpected outcomes or impacts?

The event did not generate any unexpected outcomes or impacts.

**Was your organization able to achieve your program goals?** If yes, how? If not, what improvements can be made for future programs/events?

Overall, we were able to achieve our artistic goals as well as our goal to bring cultural awareness of Ambient electronic music to the local Louisville arts community. After executing the event in 2021 under COVID restrictions, our goal for 2023 was to return to the original project vision and perform with a live audience at the Louisville Center for the Arts. We were able to achieve this goal with an audience of 36 individuals for the 2023 event.

For future events, we would like to increase the marketing exposure to get to our goal of 60 individuals in attendance. Due to technical logistics with lights and sound, the layout of the room, and fire code restrictions of the building, 60 seated audience members is the max capacity feasible for the event.

#### Outcomes:

### How did you measure your progress towards achieving your goals for this activity?

After the event announcement via Facebook, we were tracking online event stats on the Facebook event.

Number of people reached with Facebook event: ~1000 Responses to Facebook event: 86 (43% increase over 2021 event) Attendees at event: 36 (41% conversion rate from Facebook event)

#### How do these measures show you made a difference in the local community?

After the event, we received very positive feedback from audience members on the performances and the overall event. Audience members specifically commented on the quality of the production and how well the Louisville Center for the Arts suited the musical programming.

**Lessons Learned:** Evaluations often reveal opportunities for improving programs/events. Did your organizations gain new insight to your program based upon lessons learned?

Overall, we were happy with how the performances turned out and with the response we have received. Effective marketing and as a result conversion of interested individuals to actual turnout continues to be a challenge.

For future events, we are planning on additional marketing strategies, for example a mailing list and a ticket system, to convert more interested individuals to actual attendees.
