### Sustainability Advisory Board Meeting Minutes

September 20, 2023

**Call to Order** – Acting Chairperson Josh Cooperman called the meeting to order at 6:35 pm.

**Roll Call** was taken and the following members were present:

#### Approval of Agenda –

Dan moved to approve the agenda; Tiffany seconded the motion. The agenda was approved by all members.

#### Approval of Meeting Minutes –

Tiffany moved to approve the meeting minutes; Dan seconded the motion. The meeting minutes were approved by all members.

#### **Public Comments –**

RJ Harrington: R.J. offered several brief comments: (1) He wanted to clarify a statement from a previous meeting that his home is fully electrified not just because it uses a heat pump, but because in addition it has all electric appliances, plus solar panels and an electric vehicle. (2) He inquired how we all

could create momentum toward encouraging City Council to approve the Resolution to move forward with major aspects of the recently completed Internal Decarbonization Plan. (3) He is still not clear how residents like himself can learn about the ongoing work of the Community Decarbonization Plan.

#### Staff Update -

Kayla reported that City Council received an update on the ongoing Community Decarbonization Plan at their meeting on Sept. 19th. Kayla listed a number of activities scheduled to take place during October: Oct 2: There will be a meeting to discuss the Dark Sky initiative for Louisville, Oct. 7: Ecotoberfest, to be held at Community Park. (Board member Tiffany expressed interest in applying for a booth at that event.), Oct. 10: City Council will hold a study session in preparation for its decision whether to approve a Resolution to move ahead with the Internal Decarbonization Plan, and which parts of the Plan to prioritize, Oct. 25: Solar United Neighbors will hold a second outreach meeting, this one at the Boulder Library, to attract additional potential participants for their bulk purchase for rooftop solar for area residents. (Solar United's previous meeting, at the Lafayette Library, was well attended.)

#### Discussion Item – Annual Sustainability Update

Kayla presented to the Sustainability Advisory Board her preliminary overview of the past year's progress on Key Sustainability Performance Indicators and Climate Action Goals. This presentation consisted of 14 charts addressing a range of sustainability issues, including some that fall within the City Council's Work Plan for 2023, and some that carry over into their Work Plan draft for 2024.

A revised version of this presentation will be delivered to Louisville's City Council later in the fall. At the meeting, Kayla presented a modified version of the above set of presentation charts showing some additions and corrections.

#### **Public Comment**

RJ Harrington: R.J. recommended that the full emissions be clearly reported, followed with explanations of how the City incorporates the external carbon-free sources to compensate for residual carbon emissions from its use of electricity from Xcel Energy's grid.

#### LSAB Discussion

Regarding the chart titled "Discussion Item: Annual Sustainability Update - Reporting", John was curious that the entry "Sustainability Key Performance Indicators – Community GHG emissions" was so much lower than the GHG emissions listed for Louisville in the 2021 Boulder County GHG Report.

Kayla explained that her tally of Louisville's GHG emissions (carbon footprint) included only the emissions from the electricity and natural-gas usage reported by Xcel Energy in its annual community reports. Thus, emissions from transportation (and other sources) compiled in Boulder County's report are not included, for the sake of consistency in her reporting.

Regarding the entry "Internal and Community Decarbonization Plans (high priority)" in the chart titled "Discussion Item: Annual Sustainability Update –City Council Work Plan", Tiffany asked if it were possible to create a few basic, high-level charts that would convey to City Council the clear value of adopting the Resolution to proceed with the Internal Decarbonization Plan. Several attendees agreed to consider ways to do this.

Regarding the chart "Discussion Item: Annual Sustainability Update – Regional Groups", members expressed admiration that Kayla has been able to maintain productive relations with this large list of regional organizations which are

focused on various aspects of climate change and sustainability issues.

John commented that the value of all these local organizations could be judged by answering the question, "How much carbon dioxide have their activities prevented?" Another view of their value could be that, being well established, they could serve as a network to help respond to a future climate crisis.

Regarding a chart that included some last-minute updates, Kayla expressed ambivalence about how best to report the continuing "100% carbon-free electricity" that the City of Louisville has achieved during recent years. Some of this fully-renewable electricity has depended on City lease agreements with area solar farms, and also with purchases of WindSource power from Xcel Energy, to make up for the carbon-base of grid-derived electricity that the City necessarily uses (which is 48% carbon-based, as of 2023).

#### Sub-Committee and Board Member Updates –

#### Administrative Tasks –

Kayla encouraged Sustainability Advisory Board members to attend the City Council meeting (scheduled for Oct. 10) to support the approval of the Resolution to proceed with the Internal Decarbonization Plan.

Kayla asked Board members to bring to the upcoming November meeting their suggestions for tasks to include in Sustainability's Work Plan for 2024.

Kayla announced that LSAB would not hold a meeting in December because of the date's proximity to the holidays, but instead there would be a joint meeting with Lafayette's and Superior's sustainability organizations in early December.

#### **Projects and Programs**

- The Green Business Program Recognition event will be held on Thursday, December 14 from 8:00 9:00 a.m. at the Lafayette Public Library. This event is open to all businesses and to the public.
- The Northern Water landscape templates will be unveiled at an open house event on Monday, December 11 from 5:30 – 7:30 p.m. at the Louisville Recreation & Senior Center. These firewise/waterwise templates can be used by residents rebuilding from the Marshall Fire or for any new development on the Front Range.
- The new bag tax programs are launching in January 2024 and are open to all businesses
  that have remitted bag tax. The \$1,000 zero waste grant has been expanded to a more
  broad sustainability grant and can be used for any commercial sustainability project,
  including decarbonization.
- The new EE/electrification rebates are available on the <a href="EnergySmart website">EnergySmart website</a>. Find more detailed information about eligible measures <a href="here">here</a>.
  - These rebates are highlighted in the Winter Community Update, November enewsletter and November utility bill insert.
  - Louisville will be adding electric panel upgrade rebates to the current list of rebates in January 2024.
- The renewable energy portfolio is published and available on the City's Sustainability Energy sub-page.
  - This portfolio will be included in the Winter Community Update.
  - Windsource has been rolled into the new Renewable Connect Flex program is open for enrollment. Program costs have decreased from .015/kWh to .01/kWh. Customers can enroll in RC Flex using this form and emailing it to renewableconnectco@xcelenergy.com. Subscribing in this program will increase Louisville's percentage of renewable energy (unlike solar gardens). The renewable energy portfolio is being updated to reflect this change.



  - Assure that Planners' visions come to fruition



**Provide Monthly Oversight of Internal Decarb Progress** 



#### **BENEFITS**

- ► Decarb Plan's seven (7) solar arrays would further reduce city-wide carbon footprint (about 1.7%)
- ► Beginning the installations would send a message: Louisville is serious about climate change
- ▶ Visibility of installations could inspire positive acceptance of follow-on city-wide Decarbonization
- ► Energetic build-out would demonstrate City Government's strong managerial capability ("Tax dollars at work")

### (from 10/10/23 Council Presentation) If staff is directed to explore EPC –

- 1. DOLA and CEO grant applications and awards
- 2. Execute non-binding Memorandum of Understanding with CEO
- 3. Issue RFP for project scope **or** leverage CEO's prequalification process
- 4. Staff selects energy service company (ESCO)
- 5. Finalize project design, equipment selection, scope and any on-going costs (O&M)
- 6. ESCO delivers final pricing and EPC construction proposal
- 7. RFP issued for loan total
- 8. Staff selects lender final interest rates and loan terms are determined
- 9. Staff returns to Council with loan terms/loan agreement and EPC construction proposal for approval
- 10. Begin project implementation and secure Investment Tax Credits for solar (if applicable)

### ► Review and set priorities on recommendations expected from City-Wide Decarbonization Study

- Prioritize by feasibility
- Prioritize by carbon-reduction impact
- Prioritize by residents' receptivity (aid by increasing outreach)

#### ► Develop a schedule and content for outreach materials:

- Quantify benefits to residents (including CO<sub>2</sub> reductions)
- Inform residents about subsidies, rebates, long-term savings

#### ► Plan in-person activities to promote "electrification"

- Circulate frequent newsletter articles re: benefits & activities
- Host monthly Induction Stove demos by area chefs (Held at Rec Center, commercial venues, etc.)
- Sponsor frequent "house tours" showcasing heat pumps, etc.
- Lead brain-storming sessions to develop other outreach ideas

#### ►Use metrics to track effectiveness of these promotions

- Record installation counts from vendors; Work Permits; etc.
- Learn from and compare with what other area cities are doing



LSAB should create a succinct yet thorough document, intended to be distributed to residents (and potentially businesses), that details how to go about reducing one's carbon footprint.
