

It's my understanding that this project went to the Historic Planning Commission in April 2023 for Demolition Review, Probable Cause, and Design Referral. With probable cause approval, the applicant received a grant for up to \$9,000 to reimburse the costs of a historic structure assessment.

I don't believe there has been any other historic preservation funding awarded at this time.

Hi Mike,

The request for property tax increment rebate funding for 916 Main Street is capped at \$200,000. It's estimated that over a full 10-year period, the applicant would receive approximately \$136,668 in funding. The higher cap allows for additional funding in the event that the future value of the property is higher than anticipated.

The project has also been approved for Façade Improvement Program funding. This funding is limited to 50% reimbursement of eligible project costs, not to exceed \$154,267. This amount was also included in the financial analysis and calculations to determine the project gap on which the application for property tax increment rebate assistance is evaluated.
