VI. Red Tail Ridge: Landscape Planting Schedule review

Public comments:

- Agree with elimination of junipers
- Why were some other native plants substituted for non-native?
- Why did High Plains recommend certain plants?
- Cottonwoods and Willows together are needed as native plants
- Do PPLAB recommendations go to Open Space Advisory Board can we restore land to native species?
- Mindful that native environment is primarily grass and trees in wet areas - providing non-natural habitat for non-native bird species, some native bird species won't return due to the trees
- Recommend we look more at the natural side

Board Discussion

- Metro district will maintain the landscaping and plantings
- It is a courtesy that we are being asked for input

- Overall looks like a good balance of non-native vs. native plants, low-water needs
- Mahonia vs. juniper do we recommend pulling all juniper? Junipers do add all year color, do we need to pull all of these if they are not near buildings and in the right-of-way areas?
 - O Junipers can accumulate dead needles even on median strips, they could blow; some of them are not native
- Suggest color of flowering variety of plants
- Explore other succulents beyond yucca

Board's recommendations on plantings:

- Appreciate the opportunity to provide input
- Appreciate amount of native plantings
- Concur with Staff items with the exception of item c)
- Differ from staff on item c) and would like to see weigela eliminated
- Encourage the use of colorful species for spring, summer, and autumn (or year-around, if possible)
- Emphasize safety and sight-line visibility; lower-growth for sight lines and safety to be priority (e.g. wheatgrass is troublesome)
- Encourage spacing between plantings as well as alternating putting plants closer together - renderings look good
- Heat-island effect was taken into consideration based on renderings; looks like there is a good balance in renderings, and good balance of plantings and not too much rock
- Mulching and materials: Is there on-site composting for RTR? Question for Metro District.
- May want to consider spaces for public art via Cultural Council
- Consider space for Louisville gateway signage, landmark, or Tree or Bee City signs (beyond Campus Drive)

- Purpose of these signs is to provide a sense of pride for the City, sense of location

Compostable vs. plastic bags

- Open space crew noted they will be putting compostable bags in dog waste posts around town
- Compostable bags only at dog park
- Need to mark compostable ONLY in the compostable bin
- Might want to re-look at this, so plastic bags don't contaminate compostable bin

Tree removals and pruning questions:

- 3 dead trees are on list for removal near library
- Trees in median close to police station should be on list for removal by the end of the month
- Some Ash trees near S. Boulder and Eisenhower may eventually be a safety issue on list for pruning contract


